<u>Request-</u> Request for recommendation of approval of an agricultural subdivision of the Child's Lot in the proposed location.

Background: Grace Rosier, owner of the subject property, is requesting Board review and recommendation for a Child's Lot for her daughter, Jennifer Wolinski. Ms. Wolinski's sister had taken the other child's lot on August 27, 2013 and there are no remaining rights with the farm.

Ms. Wolinski has requested for the lot to be located at the edge of the farm on Freeland Road. The lot location area which she selected was forwarded to EPS for review. EPS did not find any issues with the location.
