Legislative Committee Update

- United Seniors of Maryland (USM) are tracking 43 bills and they have not yet sent an update on the status of the bills.
- USM held a caucus yesterday in Annapolis.

- The Governor's FY 18 budget has no new taxes or fees and reduces budgets across the board
- A sick leave bill for businesses with 15 or more employees has passed for the Governor's signature. If vetoed, there may be enough votes to pass.
- Maryland has passed and sent to the Governor the nation's first legislation on drug price gouging. Fines are \$10,000 for each violation and price increases could be ordered by a judge to be reversed.
- A bill was submitted to the Governor giving tax breaks for businesses creating manufacturing jobs in economically depressed areas in Maryland.
