May 24, 2016, in which the citations for violations under the Baltimore County Zoning Regulations

(BCZR) Sections 101 and 102.1 for failure to remove contractors equipment storage yard and illegal home occupation were upheld and a civil penalty was imposed of \$6,000, all but \$2,000.00 was suspended.
