## **OPINION**

This matter comes before the Board of Appeals for Baltimore County (the "Board") as a Record Appeal from Code Enforcement Hearing on March 23, 2016 and Administrative Law Judge's ("ALJ") Findings of Fact and Conclusions of Law dated March 25, 2016 regarding a Tobacco Enforcement Citation at the Omega Grocery, 222 North Point Blvd, Baltimore, Maryland 21224 which the business owner was found to be in Violation of Baltimore County Code Article 13, Title 12, Section 13-12-103, for the distribution of tobacco products and/or paraphernalia to a minor. Albert Matthew Miller, Esq. appeared on behalf of Omega Grocery and Assistant County Attorney, Renee Phillips-Farley, appeared on behalf of Baltimore County. As a result of the hearing before the ALJ, the business owner was fined Five Hundred Dollars (\$500.00.)

## **BACKGROUND**

As this case comes before the Board as a Record Appeal, the Board's review of the Hearing Officer's decision is solely based on the audio record of the March 23, 2016 Code Enforcement Hearing that the Board was provided and the oral argument presented before the Board at the May 24, 2016 Appeal Hearing.

### In the matter of Omega Grocery, LLC/CBA-16-039

The record reflects that on February 23, 2016, pursuant to Section 13-12-103, and 13-12-103.1 of the Baltimore County Code, Health Enforcement Officer (HEO) Fahad Chunghati issued a Code Enforcement Citation to the Omega Grocery. The citation came as a result of a Tobacco Compliance Assistant (TCA) under the age of 18, acting under the direct supervision and observation of HEO, Chughtati, entering the Omega Grocery and attempting to buy a tobacco product. The clerk sold tobacco products to the TCA without requesting identification and a citation was issued. Omega Grocery proprietor, Juan Nunez did not contest the allegations, but stated that his clerk was distracted due to personal problems and that he would be vigilant in preventing tobacco from being sold to minors in the future.

#### **BOARD'S OPINION**

As the evidence presented by the County was uncontested at both the Code Enforcement Hearing before the ALJ and the Hearing before this Board, we will assume that the Appellant is basing his appeal on BCC § 3-6-304 (a)(3)(iv) that states that the Board of Appeals may "reverse or modify the final order if a finding, conclusion, or decision of the Code Official, the Director, or Hearing Officer . . . is unsupported by competent, material and substantial evidence in light of the entire record as submitted . . .". It is clear from the record that Omega Grocery violated Baltimore County Code Article 13, Title 12, Section 13-12-103, for the distribution of tobacco products and/or paraphernalia to a minor the premises. These facts are not disputed.

#### **CONCLUSION**

Based the findings stated above, the Board finds that the ALJ's decision of March 25, 2016 in this matter was supported by competent, material and substantial evidence and is therefore is AFFRIMED and additionally this Board AFFIRMS the \$500.00 civil penalty.
