ORDER OF DISMISSAL

This case comes to the Board on appeal from the July 26, 2017 decision from the Division of Traffic Engineering denying the requested reserved handicapped parking space at 914 Middlesex Road.

On August 24, 2017, Martha L. Balderson filed a Notice of Appeal from the decision of the Division of Traffic Engineering. A hearing was scheduled to be held before this Board on Tuesday, October 3, 2017 at 10:00 a.m., for which proper notice was given. Michael Filsinger, James Cockrell and Edward Reed, from the Department of Public Works, appeared on behalf of Baltimore County at the scheduled time of hearing; Martha L. Balderson, Applicant/Appellant, did not appear, nor did anyone appear on her behalf.


The Board convened at 10:27 a.m., and, on the record and in open hearing, the Board moved *sua sponte* for dismissal for failure to appear. Upon consideration of the fact that the Notice had the correct address and was not returned, the Board will so order.




