## C. ENROLLMENT OF BILLS

The Chairman stated that the following bills was passed by the County Council and signed by the County Executive. He certified and delivered to the Secretary, Bills 28-06, 30-06, 31-06 and 32-06.

## D. INTRODUCTION OF BILLS

<u>BILL 47-06</u>, entitled An Act for the purpose of levying and imposing a property tax for the use of Baltimore County for taxable year beginning July 1, 2006 and ending on the thirtieth day of June following; fixing the rate of county taxation for such taxable year; fixing the rate to be charged when property taxes are paid on a semi-annual basis; and generally relating to the property tax.

<u>BILL 50-06</u>, entitled An Act for the purpose of adding new landmarks to the Final Historical Landmarks List: and generally relating to the Baltimore County Historical Landmarks List.

BILL 51-06, entitled the Annual Budget and Appropriation Ordinance of Baltimore County to adopt the County Budget, consisting of the Current Expense Budget for the fiscal year ending June 30, 2007, the Capital Budget for the fiscal year ending June 30, 2007 and the Capital Program for the fiscal years ending June 30, 2008, June 30, 2009, June 30, 2010, June 30, 2011 and June 30, 2012; and to appropriate funds for all expenditures for the fiscal year beginning July 1, 2006 and ending June 30, 2007, as hereinafter indicated.

<u>BILL 52-06</u>, entitled An Act for the purpose of providing for certain changes to the Baltimore County Code and Baltimore County Classification and Compensation Plans by amending certain Pay Schedules; adding certain new class titles, codes and grades; abolishing certain job classification, codes and grades; amending certain personnel rules and regulations; providing for the application of this Act; and generally relating to the governance and compensation of the personnel of Baltimore County Government.

<u>BILL 53-06</u>, entitled An Act for the purpose of amending the law dealing with the maintenance of investment property to require the Building Engineer to order the removal of certain abandoned properties located in Commercial Revitalization Districts; and generally relating to the maintenance of investment property.

BILL 54-06, entitled An Ordinance for the purpose of authorizing and empowering Baltimore County, Maryland to borrow money in a principal amount not exceeding \$6,000,000 for land preservation to be undertaken in the ensuing fiscal years starting July 1, 2007, and to provide that the full amount of such borrowing shall be submitted to a referendum of the registered voters of Baltimore County for their approval or rejection, pursuant to Section 718 and Section 705(a) of the Baltimore County Charter.

<u>BILL 55-06</u>, entitled an Ordinance for the purpose of authorizing and empowering Baltimore County, Maryland to borrow money in a principal amount not exceeding \$17,216,000 for the purpose of community college projects to be undertaken in the ensuing fiscal years starting July 1, 2007, and to provide that the full amount of such borrowing shall be submitted to a referendum of the registered voters of Baltimore County for their approval or rejection, pursuant to Section 718 and Section 705(a) of the Baltimore County Charter.

<u>BILL 56-06</u>, entitled an Ordinance for the purpose of authorizing and empowering Baltimore County, Maryland to borrow money in a principal amount not exceeding \$3,750,000 for community and economic improvement and development projects to be undertaken in the ensuing fiscal years starting July 1, 2007, and to provide that the full amount of such borrowing shall be submitted to a referendum of the registered voters of Baltimore County for their approval or rejection, pursuant to Section 718 and Section 705(a) of the Baltimore County Charter.

BILL 57-06, entitled an Ordinance for the purpose of authorizing and empowering Baltimore County, Maryland to borrow money in a principal amount not exceeding \$54,929,000 for public operational buildings, including, but not limited to general, health, police, fire, recreation, library, senior center and jail buildings or facilities and necessary or desirable equipment to be undertaken in the ensuing fiscal years starting July 1, 2007, and to provide that the full amount of such borrowing shall be submitted to a referendum of the registered voters of Baltimore County for their approval or rejection, pursuant to Section 718 and Section 705(a) of the Baltimore County Charter.

BILL 58-06, entitled an Ordinance for the purpose of authorizing and empowering Baltimore County, Maryland to borrow money in a principal amount not exceeding \$8,320,000 for the purpose of parks, preservation and greenways projects to be undertaken in the ensuing fiscal years starting July 1, 2007, and to provide that the full amount of such borrowing shall be submitted to a referendum of the registered voters of Baltimore County for their approval or rejection, pursuant to Section 718 and Section 705(a) of the Baltimore County Charter.

<u>BILL 59-06</u>, entitled an Ordinance for the purpose of authorizing and empowering Baltimore County, Maryland to borrow money in a principal amount not exceeding \$74,503,000 for public works purposes, for the class of projects which includes, among other things, streets and highways, bridges and storm drain systems, to be undertaken in the ensuing fiscal years starting July 1, 2007, and to provide that the full amount of such borrowing shall be submitted to a referendum of the registered voters of Baltimore County for their approval or rejection, pursuant to Section 718 and Section 705(a) of the Baltimore County Charter.

BILL 60-06, entitled an Ordinance for the purpose of authorizing and empowering Baltimore County, Maryland to borrow money in a principal amount not exceeding \$5,360,000 for refuse disposal projects, to be undertaken in the ensuing fiscal years starting July 1, 2007, and to provide that the full amount of such borrowing shall be submitted to a referendum of the registered voters of Baltimore County for their approval or rejection, pursuant to Section 718 and Section 705(a) of the Baltimore County Charter.

<u>BILL 61-06</u>, entitled an Ordinance for the purpose of authorizing and empowering Baltimore County, Maryland to borrow money in a principal amount not exceeding \$72,543,000 for public school buildings, buildings for school purposes, buildings to support school operations and site projects to be undertaken in the ensuing fiscal years starting July 1, 2007, and to provide that the full amount of such borrowing shall be submitted to a referendum of the registered voters of Baltimore County for their approval or rejection, pursuant to Section 718 and Section 705(a) of the Baltimore County Charter.

BILL 62-06, entitled an Ordinance for the purpose of authorizing and empowering Baltimore County, Maryland to borrow money in a principal amount not exceeding \$6,750,000 for waterway improvement projects to be undertaken in the ensuing fiscal years starting July 1, 2007, and to provide that the full amount of such borrowing shall be submitted to a referendum of the registered voters of Baltimore County for their approval or rejection, pursuant to Section 718 and Section 705(a) of the Baltimore County Charter.

<u>BILL 63-06</u>, entitled An Act for the purpose of expanding the effect to the State of Maryland's Homeowners' Property Tax Credit Program for eligible homeowners based on certain local eligibility and benefits standards; and generally relating to tax credits for senior citizens.



A contract of sale with Lonnie D. & Cynthia M. Ledford for a partial acquisition for a highway widening area and temporary slope easement in connection with the improvements of Joppa Road.

## 2. Engagement Letter - Venable, LLP - Collective Bargaining

A contract with Venable, LLP for legal services in support for labor-related collective bargaining with two County unions.

3. Addendum No. 1 to Contract - EBL Fire Engineering - Detention Center
Addendum No. 1 to Contract with EBL Fire Engineering for increasing the compensation for contract modifications for special inspections and testing of smoke control management systems for the new Detention Center.
4. <u>Contract - Development Facilitators, Inc Inspection Services for Public Works Construction</u>
5. Contract - Tidewater, Inc Inspection Services for Public Works
6. Contract - Century Engineering, Inc Inspection Services for Public Works
Three contracts to provide inspection services for public works construction projects on an as-needed basis. Development Facilitators, Inc. will serve as will the primary contractor and Century Engineering, Inc. and Tidewater, Inc. will serve as the secondary and tertiary contractors, respectively, to provide services in the event that the primary contractors is unable to do so at the time of the request.
7. Contract - Crabtree, Rohrbaugh & Associates - Architectural Services - Detention  Center Expansion Project
A contract with Crabtree, Rohrbaugh & Associates for architectural services for analysis and review of construction claims and litigation by the County related to the Baltimore County Detention Center Expansion Project.

There being no discussion, upon motion by Councilman Moxley, seconded by Councilman McIntire, Fiscal Matters 1 through 7 were unanimously approved.

# 2. Res. 31-06 - Endorsement of Low-income elderly housing project - Garrison Forest Rd. - Weinberg Village IV

At the direction of the Chairman, the Secretary read this Resolution concerning the Local Endorsement that was approved by Resolution 13-06 on March 20, 2006 that authorized the County Executive or other authorized official to enter into a written agreement on behalf of the County with The Harry and Jeanette Weinberg Village IV, Limited Partnership (the "Owner") for the payment of stipulated amounts in lieu of regular real property taxes in order to facilitate the development of an elderly housing project to benefit low income elderly persons in Baltimore County. Mary Harvey appeared. There being no discussion, upon motion by Councilman Kamenetz, seconded by Councilman Moxley, this Resolution was unanimously approved.

## 3. Res. 32-06 - PILOT - Elderly Housing Project Weinberg Village IV

At the direction of the Chairman, the Secretary read this resolution An Amendment, pro forma, to change/remove information regarding the Pilot (Payment in Lieu of Taxes) and to mention the Department of Housing and Community development of the State of Maryland financing of the project designated in Resolution 14-06 and approved by the Council on March 20, 2006 to authorize the County Executive or other authorized official to enter into written agreement on behalf of the County with The Harry and Jeanette Weinberg Village IV, Limited Partnership (the "Owner") for the payment of stipulated amounts in lieu of regular real property taxes in order to facilitate the development of an elderly housing project to benefit low income elderly persons in Baltimore County. Mary Harvey appeared. There being no discussion, upon motion by Councilman Moxley, seconded by Councilman Kamenetz, this Resolution was unanimously approved.

## 4. Res. 33-06 - Planning Board - Zoning Regulations - Standards for changeable copy signs

At the direction of the Chairman, the Secretary read this Resolution requesting the Baltimore County Planning Board to review the Zoning Regulations relating to the standards for changeable copy signs. There being no discussion, upon motion by Councilman Kamenetz, seconded by Councilman McIntire, this Resolution was unanimously approved.
