  - 2. On page 2, in line 4, strike "HOMEOWNER'S" and substitute "HOMEOWNERS"
  - 3. On page 3, strike lines 13 through 21, and strike all of page 4, and on page 5, strike lines 1 through 14.

- 4. On page 5, in line 15, strike "(10)" and substitute "(4)"; strike line 19 and substitute "(a) \$3000,000; OR"
- 5. On page 6, strike lines 3 through 7; strike lines 17 through 21 and substitute "PROPERTY TAX CREDIT DOES NOT EXCEED \$200,000."
- 6. On page 7, in lines 6,7,8, and 9, strike, in each instance, "INDEXED COMBINED INCOME LEVEL" and substitute "\$4,000 OF COMBINED INCOME"; in line 10, strike "5<sup>th</sup> INDEXED COMBINED INCOME LEVEL" and substitute "AMOUNT OF COMBINED INCOME IN EXCESS OF \$16,000"; and strike lines 11 through 17.

Councilman Moxley seconded the motion and these amendments passed by the following roll call vote:
