<u>BILL 92-06</u>, entitled An Act for the purpose of amending the 2006-2007 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from state funds and made available to the County through the Governor's Office of Crime Control and Prevention (GOCCP).

<u>BILL 93-06</u>, entitled An Act for the purpose of permitting an animal grooming facility in B.L., M.L. and M.H. Zones as a matter of right, subject to certain conditions; defining terms; eliminating the definition of dog grooming facility; eliminating references to dog grooming facility in certain sections of the regulations; requiring the operator of an animal grooming facility to meet certain standards; establishing certain standards for the operation of an animal grooming facility; and generally relating to animal grooming facilities.

2. <u>Contracts - (3) - Employment, Training & Education Services for eligible County</u> Youth

Three contracts with Baltimore County Public Schools, First Step, Inc. and Catapult, LLC to provide employment, training and education services for the youth Employment and Training Program.

3. <u>Contract - Environmental Quality Resources, LLC - On-call Environmental</u> Restoration Services

A contract with Environmental Quality Resources, LLC to provide various environmental restoration services including design, construction, landscape, survey and repair services throughout Baltimore County.

4. Contract of Sale - William Raymond Dickerson, trustee of the William Raymond
Dickerson Trust - Purchase of 1 apartment building located at 2631 Yorkway

A contract of sale with William Raymond Dickerson, Trustee of the William Raymond Dickerson Trust to purchase one apartment building known as 2631 Yorkway to be used for redevelopment and/or recreational purposes.

5. <u>Contract of Sale - John E. Edmonstron - Purchase of 1 apartment building located at 2615 Yorkway</u>

A contract of sale with John H. Edmonston to purchase one apartment building known as 2615 Yorkway to be used for redevelopment and/or recreational purposes.

6. <u>Addendum Agreement - Maintenance & Support Agreement - PensionGold Software - Levi, Ray & Shoup, Inc. - Employees' Retirement Systems</u>

An addendum to the maintenance and support agreement for PensionGold Software with Levi, Ray & Shoup, Inc. to provide continued maintenance and support for 3 years to the Baltimore County Employees Retirement System.

10. Contract - People Encouraging People, Inc. - Transitional Age Youth Services

A contract with People Encouraging People, Inc. to provide mental health and other required services to youth transitioning from the children's mental health system to adult system.

1. Res. 49-06 - Prioritizing list of Rural Legacy Applications

At the direction of the Chairman, the Secretary read this Resolution to rank five Rural Legacy Area Plan applications submitted to the Maryland Department of Natural Resources for consideration and approval by the Maryland Rural Legacy Board for funding in fiscal year 2007. These plans include the Baltimore County Coastal Area, Gunpowder River, Long Green Valley Area, Manor Area and Piney Run Area. David Carroll appeared. There being no discussion, upon motion by Councilman Moxley, seconded by Councilman Oliver, this Resolution was unanimously approved by the six Councilmembers present.

2. Res. 50-06 - Extension of Loreley Beach Wastewater Collection System - 5th District

At the direction of the Chairman, the Secretary read this Resolution for the purpose of approving the extension of the sanitary sewer system of Baltimore County in the White Marsh Area, Eleventh Election District and Fifth Councilmanic District of Baltimore County. Bill Korpman appeared. There being no discussion, upon motion by Councilman Oliver, seconded by Councilman Gardina, this Resolution was unanimously approved by the six Councilmembers present.

3. Res. 51-06 - Property Tax Exemption - Leon Scott, Jr.

At the direction of the Chairman, the Secretary read this Resolution to approve the refund of certain real property taxes collected from Leon Scott, Jr., who is entitled to an exemption from State and County real property taxes by reason of the exemption afforded to disabled veterans under State law. There being no discussion, upon motion by Councilman Oliver, seconded by Councilman Moxley, this Resolution was unanimously approved by the six Councilmembers present.

4. Res. 52-06 - Adopt the 2005 Land Preservation, Parks and Recreation Plan to Master Plan 2010

At the direction of the Chairman, the Secretary read this Resolution to adopt the Baltimore County 2005 Land Preservation, Parks and Recreation Plan as a part of the Baltimore County Master Plan 2010. There being no discussion, upon motion by Councilman Moxley, seconded by Councilman Oliver, this Resolution was unanimously approved by the six Councilmembers present.

5. Reappointment - Revenue Authority - Joseph E. Blair, Jr.

At the direction of the Chairman, the Secretary read the correspondence from the County Executive, requesting Mr. Joseph E. Blair, Jr., for reappointment to the Baltimore County Revenue Authority. There being no discussion, upon motion by Councilman Moxley, seconded by Councilman Oliver this Resolution was unanimously approved by the six Councilmembers present.

6. Correspondence

At the direction of the Chairman, the Secretary read the correspondence from the Office of Budget and Finance listing the non-competitive awards made during May and June, 2006.

7. Res. 53-06 - Endorsement of application by Dundalk Renaissance Corp. - Community Legacy Application

At the direction of the Chairman, the Secretary read this Resolution to endorse the filing of an application by the Dundalk Renaissance Corporation. There being no discussion, upon motion by Councilman Olszewski, seconded by Councilman Moxley, this Resolution was unanimously approved by the six Councilmembers present.

There being no further business to come before the Council at this time, upon motion by Councilman Moxley, seconded by Councilman Oliver, the meeting adjourned at 6:20 P.M.
