BALTIMORE COUNTY COUNCIL MINUTES LEGISLATIVE SESSION 2007, LEGISLATIVE DAY NO. 20 November 5, 2007 7:00 P.M.

A. The meeting was called to order by Councilman Kamenetz serving as Chairman Pro Tem at 7:00 P.M. F. APPROVAL OF FISCAL MATTERS

Councilman Kamenetz stated that the Council would now consider Fiscal Matters. Extensive testimony on each item was taken at the Council's work session on October 30, 2007. The witnesses who testified at the work session were available to restate their testimony if needed. If a Councilmember had any questions regarding a particular Fiscal Matter, that item would be discussed as a separate matter. Councilman Kamenetz then called upon the Secretary to read the cover letters for Fiscal Matters 1 through 7.

1. <u>Contract - Community Assistance Network, Inc. (CAN) - Westside Overnight</u> Shelter

A contract with Community Assistance Network, Inc., for the operation of a westside overnight shelter for homeless men and couples on the grounds of the Spring Grove Hospital Center in Catonsville. The shelter will also operate a data resource center.

2. <u>Memorandum of Understanding - State of Maryland - Office of the Public</u> Defender - Services for Pretrial Inmates

A memorandum of understanding with the State of Maryland, Office of the Public Defender, to provide services for the pretrial inmates incarcerated in the Department of Corrections.

3. Addendum to Contract - MD Industrial Trucks, Inc. - TV trucks for Sewer and Storm Drain Inspections

An addendum to the contract with MD Industrial Trucks, Inc., to increase the total compensation amount due to the total number of TV trucks that are used to visually inspect sanitary sewer and storm drain pipe via closed court video.

4. Contract of Sale - David Smith & Jennifer Miller - Widening of Cross Road

A contract with David Smith and Jennifer Miller, to acquire a highway widening area in fee simple and a temporary slope easement to widen Cross Road.

5. Contract of Sale - John Henry and Jean Rhoe - Widening of Cross Road

A contract with John Henry and Jean Rhoe, to acquire a highway widening area in fee

simple and a temporary slope easement to widen Cross Road.

6. <u>License Agreement - National Railroad Passenger Corporation - Amtrak Rail Lines</u>

A license agreement with National Railroad Passenger Corporation, to acquire Amtrak rail lines in order to construct, maintain, repair, alter, renew, relocate and remove the underground transverse crossing of a 72-inch steel casing pipe with a 42-inch gravity sewer carrier pipe known as the Herbert Run Interceptor.

7. <u>Contract - Express Scripts - Prescription Drug Services Agreement for Medicare Retirees</u>

A Medicare Part D employer-only sponsored group waiver plan prescription drug services agreement with Express Scripts Insurance Co., for the administration of a prescription drug plan (PDP) for medicare retirees.

There being no discussion, upon motion by Councilman Olszewski, seconded by Councilman Bartenfelder, Fiscal Matters 1 through 7 were unanimously approved by the five Councilmembers present.

G. <u>MISCELLANEOUS BUSINESS</u>

1. Correspondence

At the direction of Councilman Kamenetz, the Secretary read the correspondence from the Office of Budget and Finance listing the non-competitive awards made during September 2007.

2. <u>Condemnation Petition - Michael M. Jurkiewicz - Bucks Schoolhouse Road</u> Realignment

This matter was withdrawn prior to the meeting.

3. Res. 99-07 - Award of Cable Franchise - Cavalier IPTV, LLC

At the direction of Councilman Kamenetz, the Secretary read this resolution to award a competitive franchise to Cavalier IPTV, LLC to construct, operate, and maintain a cable system in Baltimore County. Councilman Kamenetz commented. There being no discussion, upon motion by Councilman Oliver, seconded by Councilman McIntire, this Resolution was unanimously approved by the five Councilmembers present.

4. Res. 101-07 - Applications for purchase of development right easements

At the direction of Councilman Kamenetz, the Secretary read this resolution to approve

certain applications for the sale of development rights easements on property located within State Agricultural Districts or on farms that meet the State criteria for application in accordance with Agricultural Article, Section 2-509 of the Annotated Code of Maryland. David Carroll appeared. There being no discussion, upon motion by Councilman Olszewski, seconded by Councilman Bartenfelder, this Resolution was unanimously approved by the five Councilmembers present.

5. Res. 102-07 - Property Tax Exemption - Otto A. Burston

At the direction of Councilman Kamenetz, the Secretary read this resolution to approve the refund of certain real property taxes collected from Otto A. Burston who is entitled to an exemption from State and County real property taxes by reason of the exemption afforded to disabled veterans under State law. There being no discussion, upon motion by Councilman Kamenetz, seconded by Councilman McIntire, this Resolution was unanimously approved by the five Councilmembers present.

6. Res. 103-07 - Local Endorsement - Leadership Through Athletics

At the direction of Councilman Kamenetz, the Secretary read this resolution to endorse the application of Leadership Through Athletics to the Department of Housing and Community Development Community Investment Tax Credit Program. There being no discussion, upon motion by Councilman McIntire, seconded by Councilman Bartenfelder, this Resolution was unanimously approved by the five Councilmembers present.

7. Reappointment - (2) - Animal Hearing Board

At the direction of Councilman Kamenetz, the Secretary read the correspondence from the County Executive, requesting the approval of Helen Banister and Barbara Leight, for reappointment to the Baltimore County Animal Hearing Board. There being no discussion, upon motion by Councilman McIntire, seconded by Councilman Oliver, this Resolution was unanimously approved by the five Councilmembers present.
