B. APPROVAL OF JOURNAL

On page 6, in line 3, strike the first bracket; starting in line 3, strike from "a]" through "SIDEWALK" in line 7 and substitute "PARKING METER ZONES"; and after line 7, insert "(c) The Traffic Engineer may not designate a parking meter [space] ZONE in front of or adjacent to a property that is zoned residential under the county zoning regulations."; in line 9, after "space", insert "OR A PARKING METER ZONE CONTROLLED BY A MULTI-SPACE PARKING METER"; in line 10, strike the first "a" and substitute "THE"; in line 15, after "space", insert "OR A PARKING METER ZONE CONTROLLED BY A MULTI-SPACE PARKING METER"; and in line 20, after "space", insert "OR A PARKING METER ZONE CONTROLLED BY A MULTI-SPACE PARKING METER, AS APPLICABLE".
- 5. On page 7, in line 1, after "SPACE", insert "OR A PARKING METER ZONE CONTROLLED BY A MULTI-SPACE PARKING METER, AS APPLICABLE,"; in line 6, strike "An" and substitute "EXCEPT AS PROVIDED IN SUBSECTION (B) OF THIS SECTION, AN"; in line 7, strike "vehicle:" and substitute "VEHICLE"; in line 8, strike "(1) Except as provided in subsection (b) of this section,", starting in line 9, strike from "space;" through "meter" in line 11.
- 6. On page 8, in lines 3, 5, and 12, after "SPACE", insert "OR A PARKING METER ZONE CONTROLLED BY A MULTI-SPACE PARKING METER".

F. APPROVAL OF FISCAL MATTERS

The Chairman stated that the Council would now consider Fiscal Matters. Extensive testimony on each item was taken at the Council's work session on July 29, 2008. The witnesses who testified at the work session were available to restate their testimony if needed. If a Councilmember had any questions regarding a particular Fiscal Matter, that item would be discussed as a separate matter. Chairman Kamenetz then called upon the Secretary to read the cover letters for Fiscal Matters 1 through 16.

1. <u>Contract - Barb Clapp Advertising & Marketing, LLC - Marketing Campaign for</u> <u>Revitalization Districts</u>

A contract with Barb Clapp Advertising & Marketing, LLC, to research, then develop a comprehensive marketing campaign including creative design and media placement to promote Baltimore County's downtown main street commercial revitalization district.

2. BAT #09-01 - Budget & Finance - Affiliated Sante' Group - Mobile Crisis Team

A budget appropriation transfer is being requested for the necessary match to accept and appropriate grant funds from Affiliated Sante' Group awarded by the Harry and Jeanette Weinberg Foundation for purposes of expanding the Police Department's Mobile Crisis Team.

3. Contracts - (2) - Environmental Site Assessment Services throughout the County

Two contracts with EA Engineering, Science and Technology, Inc. and ARM Group, Inc., to provide consulting services for environmental site assessment services throughout Baltimore County.

4. Addendum to Contract - Guardrails ETC., Inc. - Price Increases

An addendum to the contract with Guardrails ETC, Inc., to provide reasonable remedy to market conditions by allowing price increases based on actual cost increases from manufacturer.

5. Contract - General Code, LLC - Zoning Regulations

A contract with General Code, LLC, to provide the editing, computerization (both on CD and on the Baltimore County website), and printing of the Baltimore County Zoning Regulations. In addition, the vendor is also authorized to sell the Zoning Regulations to the public as specified in the contract agreement. There is no monetary charge to the County; however, the Contractor shall be compensated for it's services by the County's agreement to allow the Contractor the exclusive right to market and sell the County's zoning regulations.

6. Contract of Sale - BWOODS, LLC - Cellular Communications Tower

A contracts of sale with BWOODS, LLC, to acquire a parcel of land at 1963 Brady Avenue, Halethorp, Maryland 21227, for the construction of a cellular communications tower for the enhancement of radio communications.

7. Contract of Sale - Mengesha H. Gebremicael - Widening of Lyons Mill Road

A contract with Mengesha H. Gebremicael, to acquire a parcel of land at 9812 Lyons Mill Road, Owings Mills, Maryland 21117, for the widening of Lyons Mill Road.

8. Contract of Sale - Melinda Woods - Widening of Lyons Mill Road

A contract with Melinda Woods, to acquire a parcel of land at 9814 Lyons Mill Road, Owings Mills, Maryland 21117, for the widening of Lyons Mill Road.

9. Contract of Sale - Triple J Joint Venture - Preservation of Agricultural Land

A contract of sale with Triple J Joint Venture, for acquisition of an easement, situated on Trenton Mill Road and approximately 65.938 acres in size, to preserve agricultural land, watershed and wetlands.

10. Addendum to Contract - Buchart Horn, Inc. - Completion of Construction Phase Engineering Services - Pikesville Reservoir

Addendum #2 to the contract with Buchart Horn, Inc., to amend the duration of the agreement to complete the construction phase engineering services for the project.

11. <u>Contract - Stanley Convergent Security Solutions, Inc. - Detention Center Security Electronic System</u>

A contract with Stanley Convergent Security Solutions, Inc., to perform troubleshooting, maintenance and repairs on the security electronics systems.

12. <u>Contract - Integrated Biometric Technology, LLC - Fingerprinting/Background Investigations - Human Resources</u>

A contract with Integrated Biometric Technology, LLC, to provide fingerprinting and background investigations for new hires within Baltimore County Government through the Office of Human Resources.

13. Contract - St. Agnes Hospital - Clinical Education for Advanced Life Support Students

Three contracts with St. Agnes Hospital. The hospital staff at St. Agnes will provide clinical education for advanced life support students from the Baltimore County Fire Department paramedic program. No funds are involved, and the agreement has an initial term of two years, thereafter, the agreement may be renewed for an additional two years.

14. <u>Lease - Denrich Family Investments, LLC t/a TH Property, LLC - Police Substation - Hillendale Area</u>

A lease with Denrich Family Investments, LLC, t/a TH Property, LLC, to establish a police substation for the purpose of creating a visible police presence in the greater Hillendale area, at 1055 Taylor Avenue, Suite 119, 21286, in an effort to reduce and prevent crime through a comprehensive community-focused strategy.

15. <u>Contract - Physio-Control, Inc. - Service, Support & Inspection for Cardiac Monitor Defibrillators</u>

A contract with Physio-Control, Inc., to provide service, support and inspections for 58 LP 12 Cardiac monitor defibrillators and their battery support systems.

16. Contract - Baltimore County Conference & Visitors Bureau, Inc. - Transitional Funding

A contract with Baltimore County Conference and Visitors Bureau, Inc., for transitional funding of the Bureau during the hiring of permanent County employees and the merger of all tourism functions into the Department of Economic Development.

Chesapeake Commercial Properties, Inc., has submitted an application for approval of a 20.5 acre site located on the east side of Red Run Boulevard, west of Owings Mills Boulevard in the Fourth Councilmanic District to be developed as a general development planned unit development known as Red Run Mills. There being no discussion, upon motion by Councilman Oliver, seconded by Councilman Moxley, this Resolution was unanimously approved.

2. Reappointment - Revenue Authority - Leslie M. Pittler

_____At the direction of the Chairman, the Secretary read this correspondence from the County Executive requesting Mr. Leslie M. Pittler for reappointment to the Baltimore County Revenue Authority. There being no discussion, upon motion by Councilman Olszewski, seconded by Councilman Bartenfelder, this reappointment was unanimously approved.

3. Res. 54-08 - Property Tax Exemption - DAV - Melvin Lewis

At the direction of the Chairman, the Secretary read this resolution to approve the refund of certain real property taxes collected from Melvin Lewis who is entitled to an exemption from State and County real property taxes by reason of the exemption afforded to disabled veterans under State law. There being no discussion, upon motion by Councilman Bartenfelder, seconded by Councilman Moxley, this Resolution was unanimously approved.

4. Res. 55-08 - Accept a gift from St. Joseph's Medical Center for the Fire Department

At the direction of the Chairman, the Secretary read this resolution to authorize the County to accept a gift for the use of Baltimore County, Maryland. St. Joseph Medical Center is donating to the Fire Department modems for cardiac monitors. Joseph Brown appeared.
