D. <u>INTRODUCTION OF BILLS</u>

BILL 6-09, entitled An Act for the purpose of permitting warehouses by special exception in a B.L. zone under certain conditions; and generally relating to warehouses.

1. <u>Correspondence</u>

2. Res. 4-09 - Metropolitan District Extension No. 153 - West Cherry Hill Court

At the direction of the Chairman, the Secretary read this resolution concerning the extension of the Metropolitan District Boundaries to include 11.211 acres of land on West Cherry Hill Court east of Franklin Boulevard and south of Northwest Expressway (I-795) for the purpose of providing public water and sewer services. Bill Korpman appeared. There being no discussion, upon motion by Councilman Bartenfelder, seconded by Councilman Moxley, this resolution was unanimously approved by the six Councilmembers present.

3. Res. 5-09- Property Tax Exemption - DAV - James F. Corrigan

At the direction of the Chairman, the Secretary read this resolution to approve the refund of certain real property taxes collected from James F. Corrigan who is entitled to an exemption from State and County real property taxes by reason of the exemption afforded to disabled veterans under State law. There being no discussion, upon motion by Councilman Moxley, seconded by Councilman McIntire, this resolution was unanimously approved by the six Councilmembers present.
