### B. <u>APPROVAL OF JOURNAL</u>

### C. <u>ENROLLMENT OF BILLS</u>

The Chairman stated that the following bills were passed by the County Council and signed by the County Executive. He certified and delivered to the Secretary, Bills 83-09, 84-09, 85-09 and 86-09.

#### D. <u>INTRODUCTION OF BILLS</u>

**<u>BILL 94-09</u>**, entitled An Act for the purpose of amending the service retirement allowance for County Councilmembers, and providing for the application of the Act.

**BILL 95-09**, entitled An Act for the purpose of amending the 2009-2010 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from federal funds and made available to the County through the State of Maryland Department of Health and Mental Hygiene.

**BILL 96-09**, entitled An Act for the purpose of amending the 2009-2010 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from federal funds and made available to the County through the U.S. Department of Homeland Security - FEMA.

**BILL 97-09**, entitled An Act for the purpose of amending the 2009-2010 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from the Chesapeake Bay Trust, Baltimore City and Harford County and made available to the County.

**BILL 98-09**, entitled An Act for the purpose of amending the 2009-2010 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from state funds and made available to the County through the State of Maryland Department of Health and Mental Hygiene.

**<u>BILL 99-09</u>**, entitled An Act for the purpose of repealing the sunset provision of the Renaissance Redevelopment Pilot Program; and generally relating to the extension of the Renaissance Redevelopment Program.

<u>BILL 100-09</u>, entitled An Act for the purpose of permitting certain restaurant and other uses in certain office buildings located in an R-O Zone; and generally relating to uses allowed by special exception in an R-O Zone.

**BILL 101-09**, entitled An Act for the purpose of amending the service retirement allowance for members of the County Council and County Executive; providing for a reduced service retirement allowance in certain cases; providing for the application of the Act; and generally relating to the service retirement allowance for members of the County Council and County Executive.

### 1. <u>Contract of Sale - Cynthia W. Murray, Anthony C. Hall & James C. Murray - Protection of Farmland</u>

A contract of sale with Cynthia W. Murray, Anthony C. Hall and James C. Murray, to acquire an agricultural easement, located at 2434 Geist Road, Glyndon, Maryland 21136, for the protection of farmland through the County Agricultural Land Preservation Program.

#### 2. Fourth Amendment to Contract - Towson University - Senior Fitness Project

Fourth amendment to the contract with Towson University to extend the Senior Fitness Project by six months, from January 1, 2010 to June 30, 2010 for fiscal year 2010. This contract amendment and extension provides health education and fitness programs to Baltimore County senior centers for senior adults.

### 3. <u>Contract - Lighting Maintenance Inc. - Maintenance and repair of athletic field and court lights (as needed)</u>

A contract with Lighting Maintenance Incorporated, to provide the maintenance and repair of athletic field and court lights on an on-call as needed basis.

## 4. <u>Lease - St. John Properties - Health Dept. - Emergency Preparedness and Response</u> <u>Equipment and Supplies</u>

A lease with St. John Properties to lease 3,000 square feet of warehouse space, located at 2187 Greenspring Drive, Timonium, Maryland 21093, for the Department of Health emergency preparedness and response equipment and supplies, for the term of five years, beginning on January 1, 2010.

## 5. <u>Contract - Lamar, Archer & Cofrin, LLP & Kevin Ross, LLC & Crongeyer Law Firm, P.C. - Legal Services - Hotel Tax Litigation</u>

A contract with Lamar, Archer & Cofrin, LLP, and the Law Practice of Kevin Ross, LLC, and Crongeyer Law Firm, P.C., to provide legal services related to hotel taxes and any and all other damages, interest, taxes and/or penalties from web-bases internet travel companies and/or clearing houses on behalf of the County.

### 2. Reappointment - Planning Board - Chairman - Ed Gilliss

At the direction of the Chairman, the Secretary read the correspondence from the County Executive requesting the reappointment of Edward J. Gilliss as Chairman to the Baltimore County Planning Board. There being no discussion, upon motion by Councilman Bartenfelder, seconded by Councilman Olszewski, this reappointment was unanimously approved.

# 3. Res. 88-09 - Accept gift of land from Sandra Graves Pletka - Open Space/Green Space

At the direction of the Chairman, the Secretary read this resolution to authorize the County to accept a gift from Sandra Graves Pletka in the form of a parcel of land containing 3.79 acres, more or less, as described on Exhibit A. Dennis Maloney appeared. There being no discussion, upon motion by Councilman Moxley, seconded by Councilman Oliver, this Resolution was unanimously approved.

#### 4. Res. 89-09 - Amendment to Water Supply and Sewerage Plan

At the direction of the Chairman, the Secretary read this resolution of the Baltimore County Council to amend the Baltimore County Water Supply and Sewerage Plan. Dave Thomas appeared. There being no discussion, upon motion by Councilman Olszewski seconded by Councilman Oliver, this Resolution was unanimously approved.

### 5. Res. 90-09 - Ranking of 14 Applications for Development Rights Easements

At the direction of the Chairman, the Secretary read this resolution to approve certain applications for the sale of development rights easements on agricultural properties located within Agricultural Land Preservation Areas. Wally Lippincott appeared. There being no discussion, upon motion by Councilman Gardina, seconded by Councilman Moxley, this Resolution was unanimously approved.

### 6. Reappointment - Animal Hearing Board - Barbara Leight

At the direction of the Chairman, the Secretary read the correspondence from the County Executive requesting the reappointment of Barbara Leight to the Baltimore County Animal Hearing Board. There being no discussion, upon motion by Councilman McIntire, seconded by Councilman Moxley, this reappointment was unanimously approved.

### 7. <u>Petition for Condemnation - Ballard Family, LLC - Extension of Owings Mills Boulevard</u>

At the direction of the Chairman, the Secretary read the correspondence from the Administrative Officer petitioning to the petition for condemnation with Ballard Family, LLC, to acquire a parcel of land, located on Lyons Mill Road, Owings Mills, Maryland 21117, for the highway project that will extend Owings Mills Boulevard from it's current terminus. Dennis Maloney appeared. There being no discussion, upon motion by Councilman Olszewski, seconded by Councilman Oliver, this Resolution was unanimously approved.
