- 2. On page 2, in line 8, after "ESTABLISHMENT", insert ", THAT IS PART OF A COMMERCIAL DAIRY FARM,"
- 3. On page 2, in line 20 and on page 4, in line 12, strike "IN" and substitute ", BUSINESS OR USE IN OR NEAR"
- 4. On page 5, strike lines 20 through 22, and on page 6, strike lines 1 and 2 and substitute the following:
- "A. THE MAJORITY OF THE MILK USED BY THE FARMSTEAD CREAMERY TO PRODUCE DAIRY PRODUCTS, ON AN ANNUAL BASIS, MUST BE PRODUCED ON THE PREMISES, ON ADJACENT LAND, OR ON PROPERTIES FARMED BY THE SAME AGRICULTURAL PRODUCER LOCATED WITHIN 25 MILES. A FARMSTEAD CREAMERY MAY NOT PROCESS MORE THAN 2,000 GALLONS OF RAW MILK PER DAY.
 - 5. On page 6, in line 6, before "FARM", insert "CONTIGUOUS"
 - 6. On page 6, strike lines 14 and 15 and substitute the following:
- "D. THIS SECTION IS NOT SUBJECT TO THE VARIANCE PROVISIONS OF SECTION 307."
