- Goal is to increase safety decrease and risk for seniors
- For families and caregivers this means
 - Action and Empowerment for families
 - o Allows them to make planned and educated decisions
 - o Provides options at a time of crisis
 - Navigate the most appropriate and best possible care
- An average cost can between \$140 \$200 an hour

Living Options

- Independent Living (IL)
- Group Home
- Assisted living (AL)
- Dementia or Memory Care
- Skilled Nursing Facility (SNF)
- Continuing Care Retirement Community (CCRC)

Insurance

- Maryland health Plans for individuals families and small business
- Maryland Medical Assistance State of md medical assistance programs mmcp.dhmh.maryland.gov
- The MD Department of health and mental hygiene provides these programs in order to improve access to health care services for low-income residents.

Medication

Medicare (Age 65 and older)

- PART A
 - Hospital insurance
 - Covers inpatient hospital care
 - Covers skilled nursing facility, and, in limited circumstances, at home.
- Part B
 - Medical Insurance
 - Covers services and supplies that are medically necessary to treat your health condition.
 - Outpatient care
 - Preventive services
 - Ambulance services
 - Durable medical equipment
 - Medicare –In most cases if you don't sign up for Medicare when you're first eligible, you'll have to pay a late enrollment penalty with higher fees.
- Part C
 - Also called Medicare advantage plan.
 - Medicare part c is optional and there is no penalty for not signing up.

- Medicare advantage plans typically cover more than original Medicare (part A and Part B).
- You must have Medicare Part A and Part B to get Part C, live in the service area of a Medicare.
- Part D
 - Prescription drug coverage
 - Provided and coordinated by Medicare-approved private insurance companies.
 - You can get Medicare Part D coverage through a stand-alone Medicare Prescription Drug Plan if you're enrolled in Original Medicare.

Medigap

- Extra health insurance that you buy from a private company to pay heath care costs not covered by Part A, Part B, and Part C.
 - Co-payments
 - Deductibles
 - Health care if you travel outside the United States.
- Medigap polices do not cover;
 - o Long-term care
 - Dental Care
 - Vision Care
 - Hearing Aids
 - Eyeglasses
 - Private-duty nursing

Initial enrollment

- Enrollment period begins three months before you turn 65 and last for seven months.
- If you miss your initial enrollment for whatever reason, you can sign up for Medicare Part A and/or Part B during the **General Enrollment Period** that runs from January 1 through March 31 of every year.

Update: 2017 Maryland Legislative Session

- HOME Act Will ensure that landlords throughout the County will treat people as individualsand not reject them solely because of the individual's source of income.
- Has been brought up several times at the State. First hearing was held last Tuesday.
 - o Five people testified in support of the HOME Act.
 - o Four people spoke against.
- Senate Bill 728 The HOME Act was submitted. Will be heard on February 28, 2017.

Workgroups

Education

- Efforts between health education and special education to train all secondary teachers on the Family Life curriculum who work in self-contained classes with students on the certificate track.
 - They are figuring out how to do this.
 - Teachers meet once a month and their supervisor has offered to use part of that meeting to do the training.
- On track to give out consistent information at strategic times to families and students.
- The Education Work Group meets on the second Wednesday of the month at 9:30am at the Odyssey School.

Housing

- Going line by line through the county's plan for CDBG money for the next 5 years.
- We're looking for recommendations that were made.
 - o Includes funding for people who do not have child under age 6 in their home to get lead paint and assistance, etc.
- Meeting 1st Thursday over every month at 1pm at the IMAGE center

Youth Reach Maryland – Maryland's first, multi-jurisdictional, comprehensive survey and census of youth and young adults struggling with homelessness.

- Looking for youth and young adults who are under the age of 25, not in the physical custody or care of parent/legal guardian, and without a fixed, regular or adequate nighttime residence.
