

# 2011 – 2012 School Adequate Public Facilities Ordinance Report and Maps



**Baltimore County Department of Planning  
January 2012**

# Report Summary

Section 32-6-103(f) of the Baltimore County Code requires that the Department of Planning furnish the School Adequate Public Facilities Ordinance Report and Maps using September 30, 2011 school enrollment data, indicating overcrowded school districts in accordance with parameters in the referenced County Code.

School system capacities based on the full time equivalent (FTE) enrollments of September 30, 2011 and current school year's state rated capacity (SRC) are presented for all the elementary, middle, and high schools in the first section of this report. The second section reviews schools that are over 115% of the SRC.

In the 2011-2012 school year, full time equivalent (FTE) enrollments of fifteen (15) elementary schools are at or over 115% of the 2011-2012 State Rated Capacity (SRC). The FTEs for all the middle and high schools are under 115% of SRC. A school impact analysis will be performed for each proposed development project to determine whether an adjacent school district is overcrowded under Section 32-6-103(f) of the Baltimore County Code.

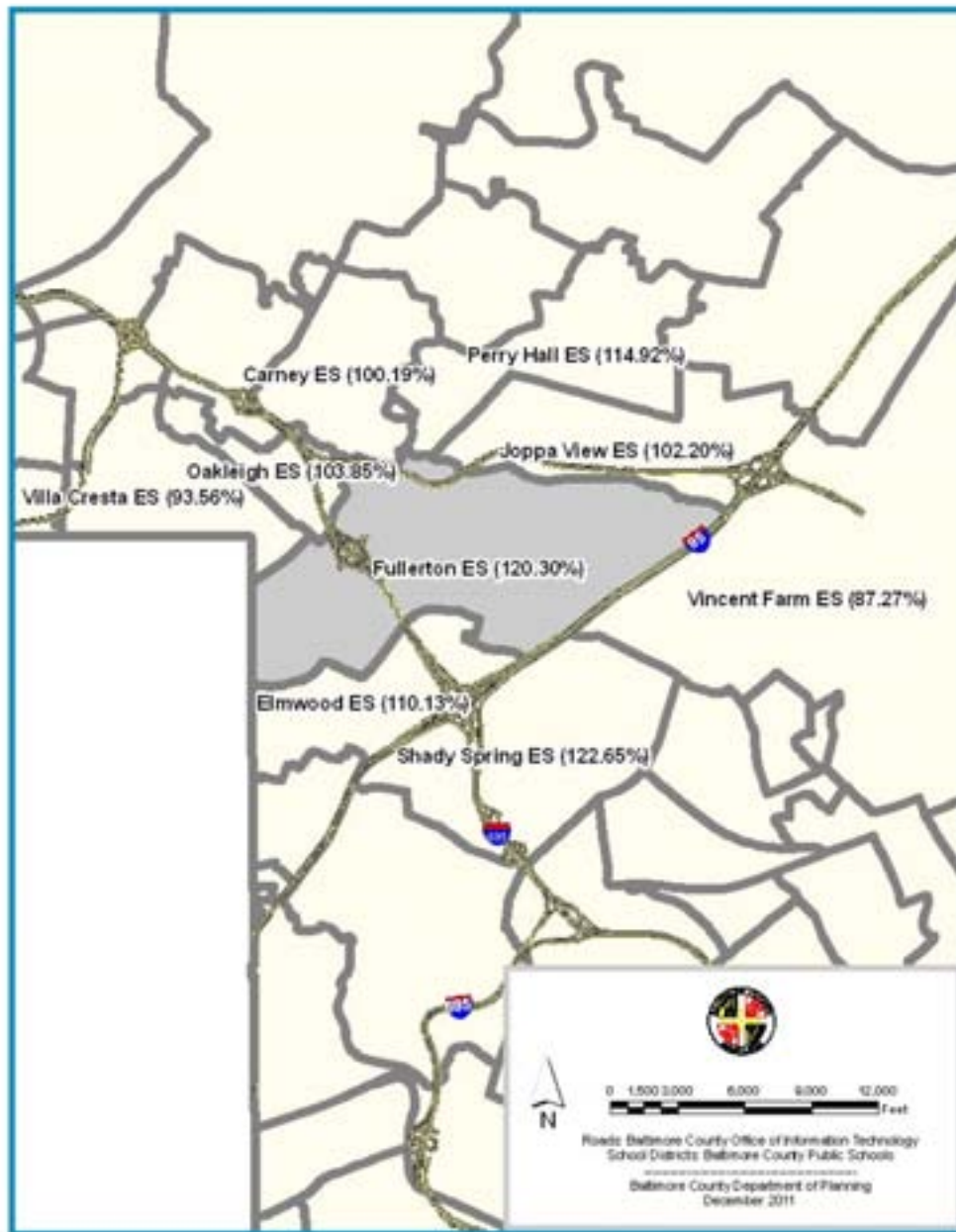

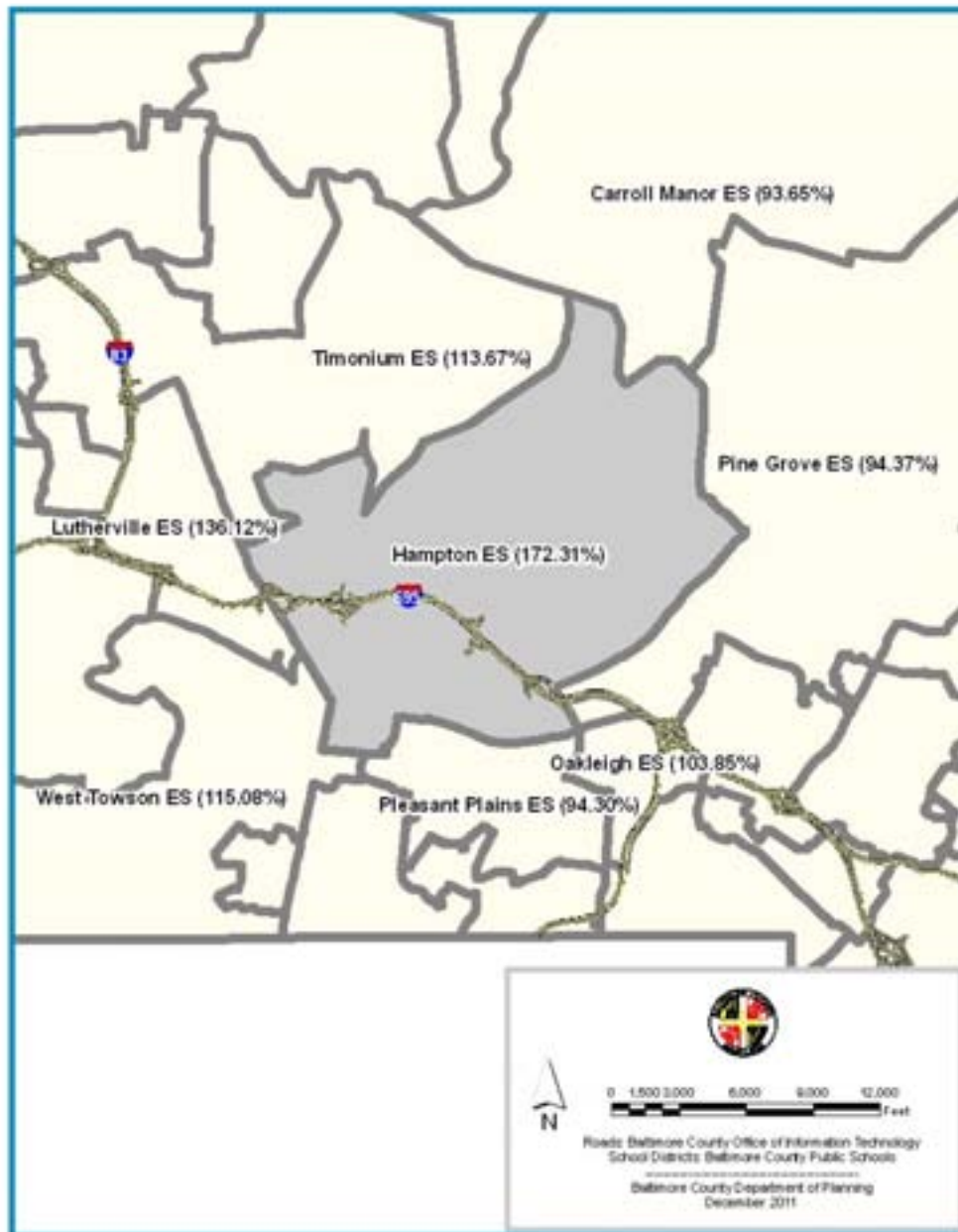

## Fullerton Elementary School



The Fullerton Elementary School's enrollment of September 30, 2011 is 557. The State Rated Capacity (SRC) for this school is 463. Based on these numbers, Fullerton Elementary School is 120.30% of SRC (See Appendix). A school impact analysis will be performed for each proposed development project to determine whether a school adjacent to Fullerton Elementary School (see map above) is overcrowded under Section 32-6-103(f) of the Baltimore County Code.

## Hampton Elementary School



The Hampton Elementary School's enrollment of September 30, 2011 is 529. The State Rated Capacity (SRC) for this school is 307. Based on these numbers, Hampton Elementary School is 172.31% of SRC (See Appendix). A school impact analysis will be performed for each proposed development project to determine whether a school adjacent to Hampton Elementary School (see map above) is overcrowded under Section 32-6-103(f) of the Baltimore County Code. The Baltimore County FY 2012 Capital Budget has \$10,000,000 funded to construct a 300-seat addition at Hampton Elementary School and to design an addition at Stoneleigh Elementary School to address overcrowding conditions along the York Road corridor. Construction funding for the Hampton addition was available starting July 1, 2011.

## Lansdowne Elementary School



The Lansdowne Elementary School's enrollment of September 30, 2011 is 401. The State Rated Capacity (SRC) for this school is 313. Based on these numbers, Lansdowne Elementary School is 128.12% of SRC (See Appendix). A school impact analysis will be performed for each proposed development project to determine whether a school adjacent to Lansdowne Elementary School (see map above) is overcrowded under Section 32-6-103(f) of the Baltimore County Code.

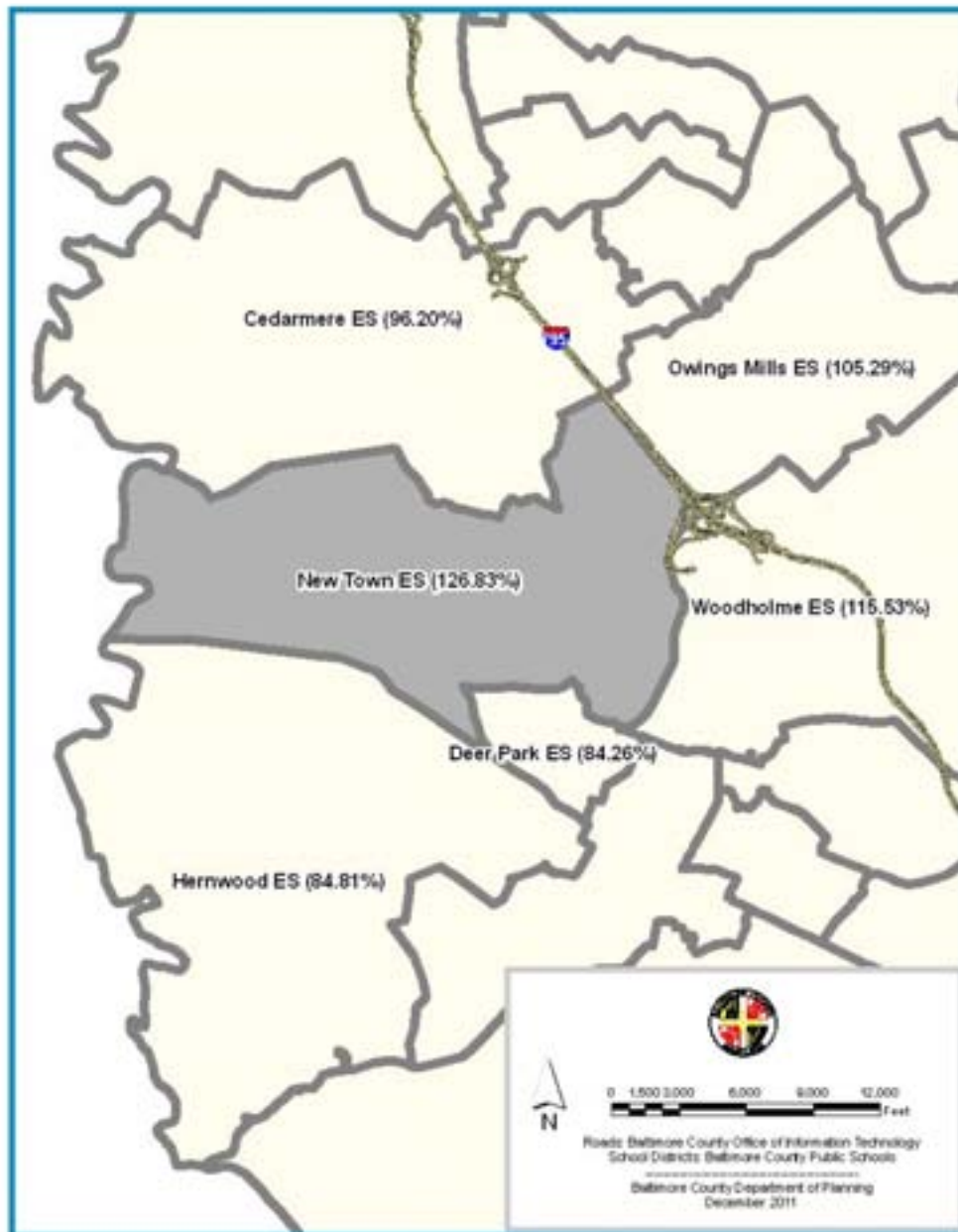
## Lutherville Elementary School



The Lutherville Elementary School's enrollment of September 30, 2011 is 554. The State Rated Capacity (SRC) for this school is 407. Based on these numbers, Lutherville Elementary School is 136.12% of SRC (See Appendix). A school impact analysis will be performed for each proposed development project to determine whether a school adjacent to Lutherville Elementary School (see map above) is overcrowded under Section 32-6-103(f) of the Baltimore County Code. The Baltimore County FY 2012 Capital Budget has \$10,000,000 funded to construct a 300-seat addition at Hampton Elementary School and to design an addition at Stoneleigh Elementary School to address overcrowding conditions along the York Road corridor. The capacity needs for Lutherville Elementary School will be examined pending a review of seats needed and overcrowding alternatives by the Baltimore County Public Schools.

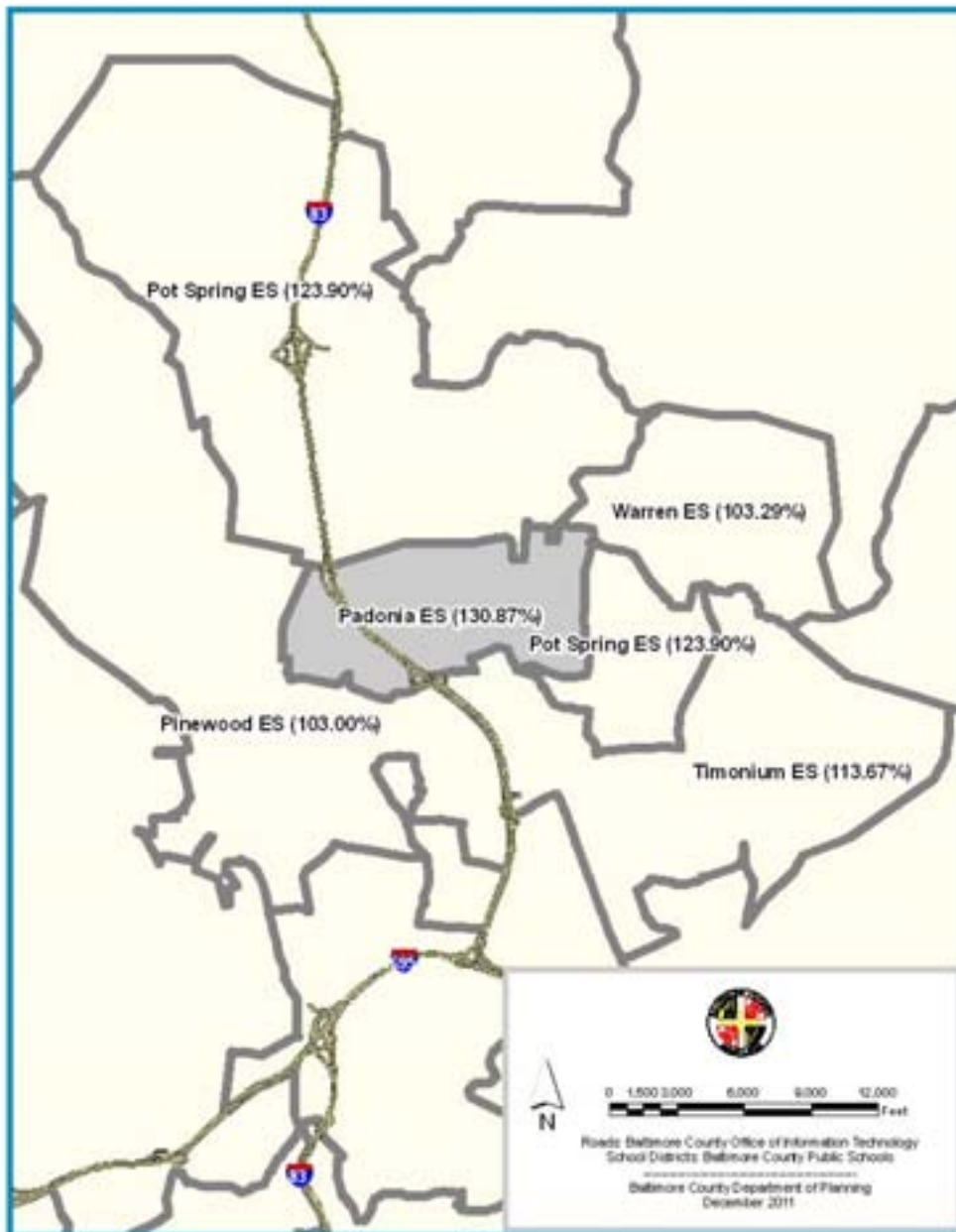


## New Town Elementary School



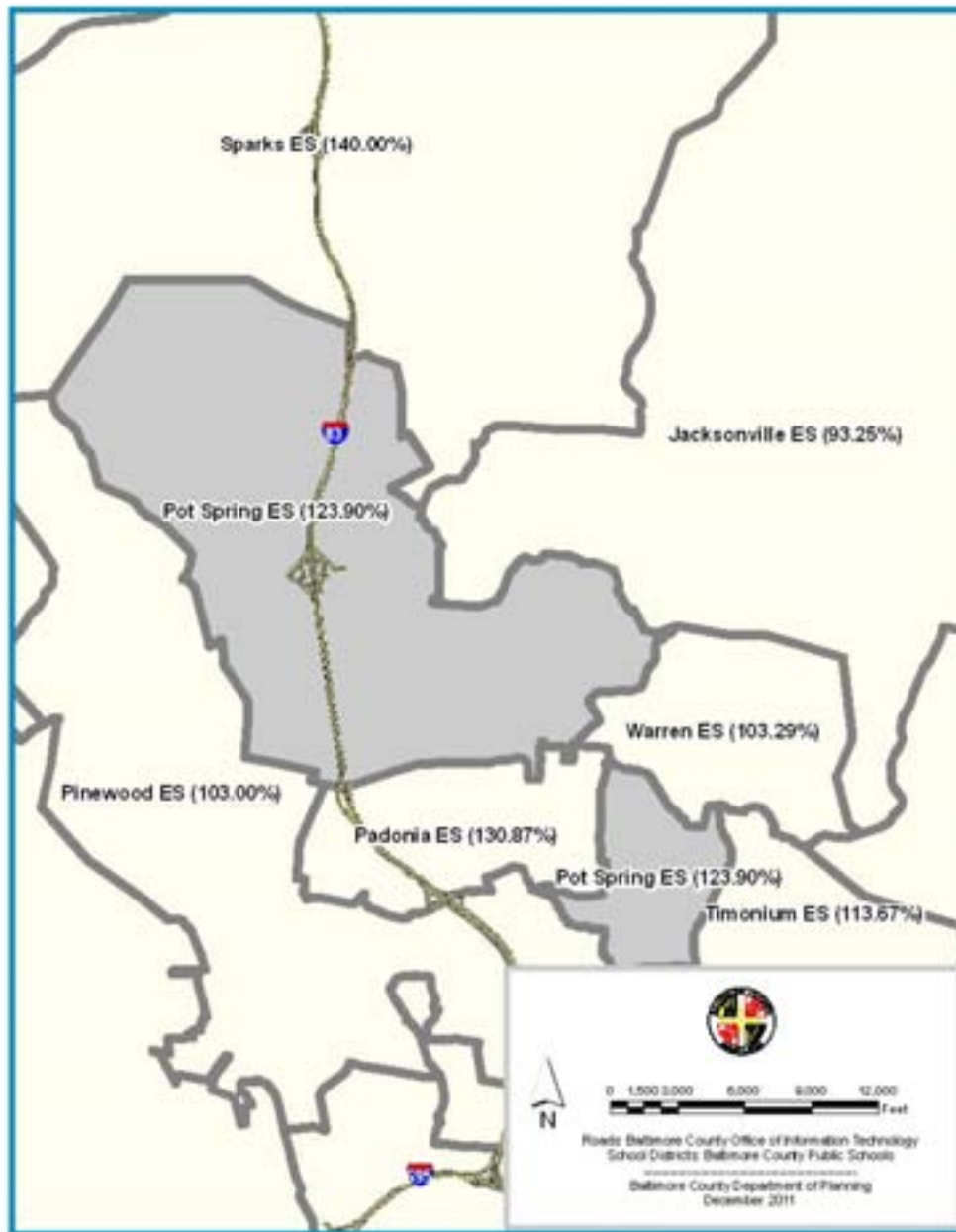
The New Town Elementary School's enrollment of September 30, 2011 is 884. The State Rated Capacity (SRC) for this school is 697. Based on these numbers, New Town Elementary School is 126.83% of SRC (See Appendix). A school impact analysis will be performed for each proposed development project to determine whether a school adjacent to New Town Elementary School (see map above) is overcrowded under Section 32-6-103(f) of the Baltimore County Code.

## Padonia Elementary School



The Padonia Elementary School's enrollment of September 30, 2011 is 407. The State Rated Capacity (SRC) for this school is 311. Based on these numbers, Padonia Elementary School is 130.87% of SRC (See Appendix). A school impact analysis will be performed for each proposed development project to determine whether a school adjacent to Padonia Elementary School (see map above) is overcrowded under Section 32-6-103(f) of the Baltimore County Code. The Baltimore County FY 2012 Capital Budget has \$10,000,000 funded to construct a 300-seat addition at Hampton Elementary School and to design an addition at Stoneleigh Elementary School to address overcrowding conditions along the York Road corridor. The capacity needs for Padonia Elementary School will be examined pending a review of seats needed and overcrowding alternatives by the Baltimore County Public Schools.

## Pot Spring Elementary School



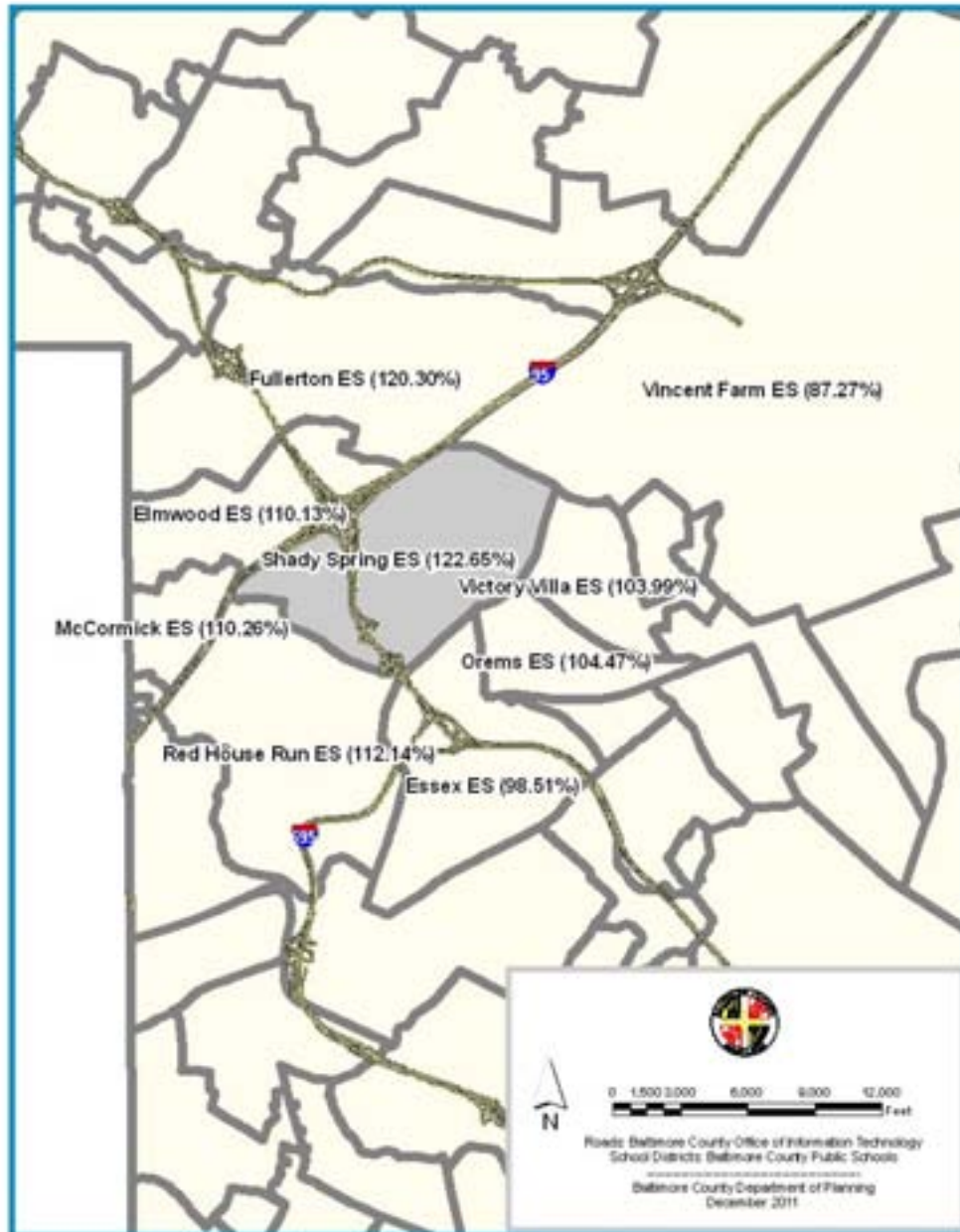
The Pot Spring Elementary School's enrollment of September 30, 2011 is 591. The State Rated Capacity (SRC) for this school is 477. Based on these numbers, Pot Spring Elementary School is 123.90% of SRC (See Appendix). A school impact analysis will be performed for each proposed development project to determine whether a school adjacent to Pot Spring Elementary School (see map above) is overcrowded under Section 32-6-103(f) of the Baltimore County Code. The Baltimore County FY 2012 Capital Budget has \$10,000,000 funded to construct a 300-seat addition at Hampton Elementary School and to design an addition at Stoneleigh Elementary School to address overcrowding conditions along the York Road corridor. The capacity needs for Pot Spring Elementary School will be examined pending a review of seats needed and overcrowding alternatives by the Baltimore County Public Schools.

## Relay Elementary School



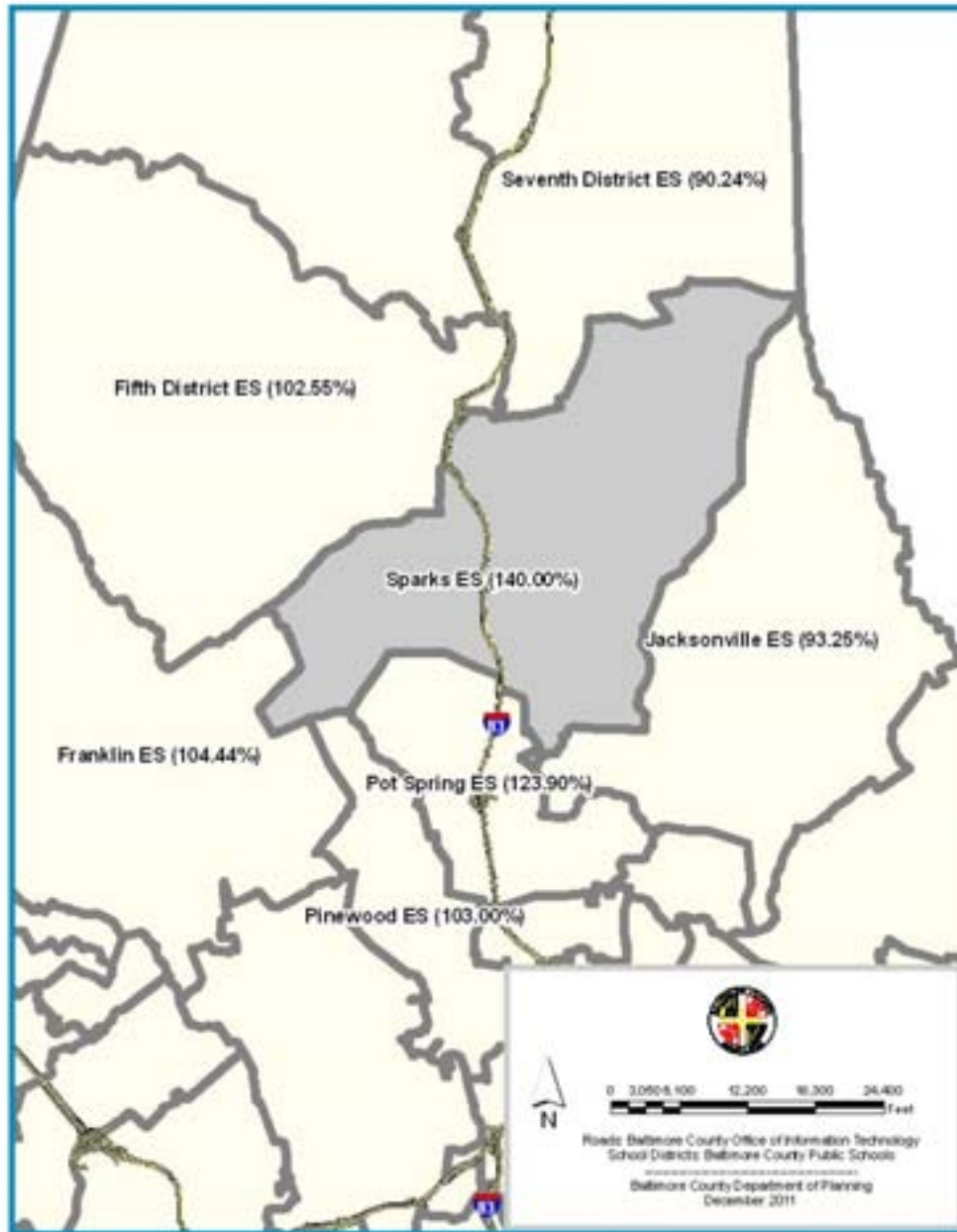
The Relay Elementary School's enrollment of September 30, 2011 is 514. The State Rated Capacity (SRC) for this school is 415. Based on these numbers, Relay Elementary School is 123.86% of SRC (See Appendix). A school impact analysis will be performed for each proposed development project to determine whether a school adjacent to Relay Elementary School (see map above) is overcrowded under Section 32-6-103(f) of the Baltimore County Code.

## Shady Spring Elementary School



The Shady Spring Elementary School's enrollment of September 30, 2011 is 612. The State Rated Capacity (SRC) for this school is 499. Based on these numbers, Shady Spring Elementary School is 122.65% of SRC (See Appendix). A school impact analysis will be performed for each proposed development project to determine whether a school adjacent to Shady Spring Elementary School (see map above) is overcrowded under Section 32-6-103(f) of the Baltimore County Code.

## Sparks Elementary School



The Sparks Elementary School's enrollment of September 30, 2011 is 574. The State Rated Capacity (SRC) for this school is 410. Based on these numbers, Sparks Elementary School is 140.00% of SRC (See Appendix). A school impact analysis will be performed for each proposed development project to determine whether a school adjacent to Sparks Elementary School (see map above) is overcrowded under Section 32-6-103(f) of the Baltimore County Code. The Baltimore County FY 2012 Capital Budget has \$10,000,000 funded to construct a 300-seat addition at Hampton Elementary School and to design an addition at Stoneleigh Elementary School to address overcrowding conditions along the York Road corridor. The capacity needs for Sparks Elementary School will be examined pending a review of seats needed and overcrowding alternatives by the Baltimore County Public Schools.

## Stoneleigh Elementary School



The Stoneleigh Elementary School's enrollment of September 30, 2011 is 675. The State Rated Capacity (SRC) for this school is 499. Based on these numbers, Stoneleigh Elementary School was 135.27% of SRC (See Appendix). A school impact analysis will be performed for each proposed development project to determine whether a school adjacent to Stoneleigh Elementary School (see map above) is overcrowded under Section 32-6-103(f) of the Baltimore County Code. The Baltimore County FY 2012 Capital Budget has \$10,000,000 funded to construct a 300-seat addition at Hampton Elementary School and to design an addition at Stoneleigh Elementary School to address overcrowding conditions along the York Road corridor.

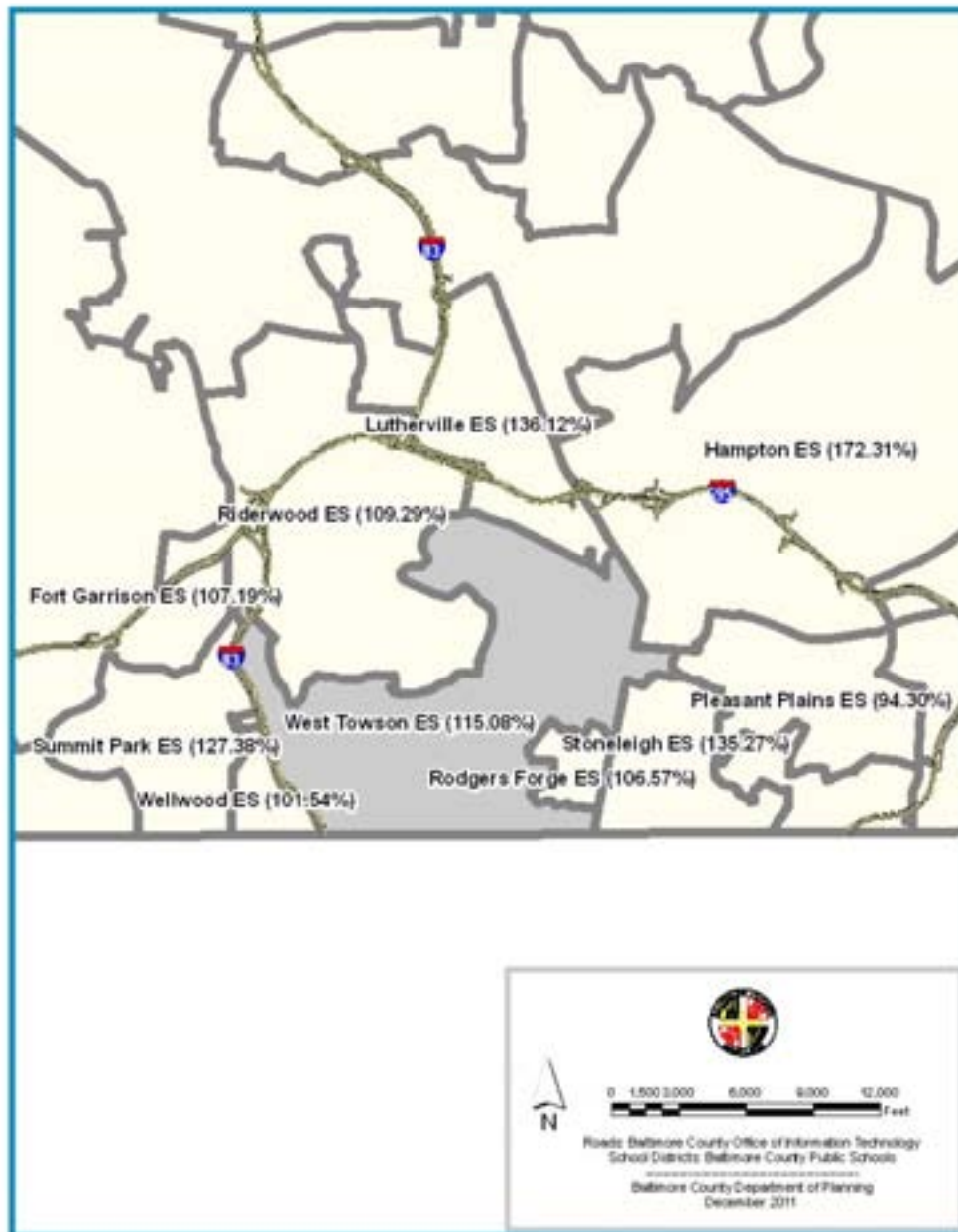
## Summit Park Elementary School



The Summit Park Elementary School's enrollment of September 30, 2011 is 428. The State Rated Capacity (SRC) for this school is 336. Based on these numbers, Summit Park Elementary School is 127.38% of SRC (See Appendix). A school impact analysis will be performed for each proposed development project to determine whether a school adjacent to Summit Park Elementary School (see map above) is overcrowded under Section 32-6-103(f) of the Baltimore County Code.



## West Towson Elementary School



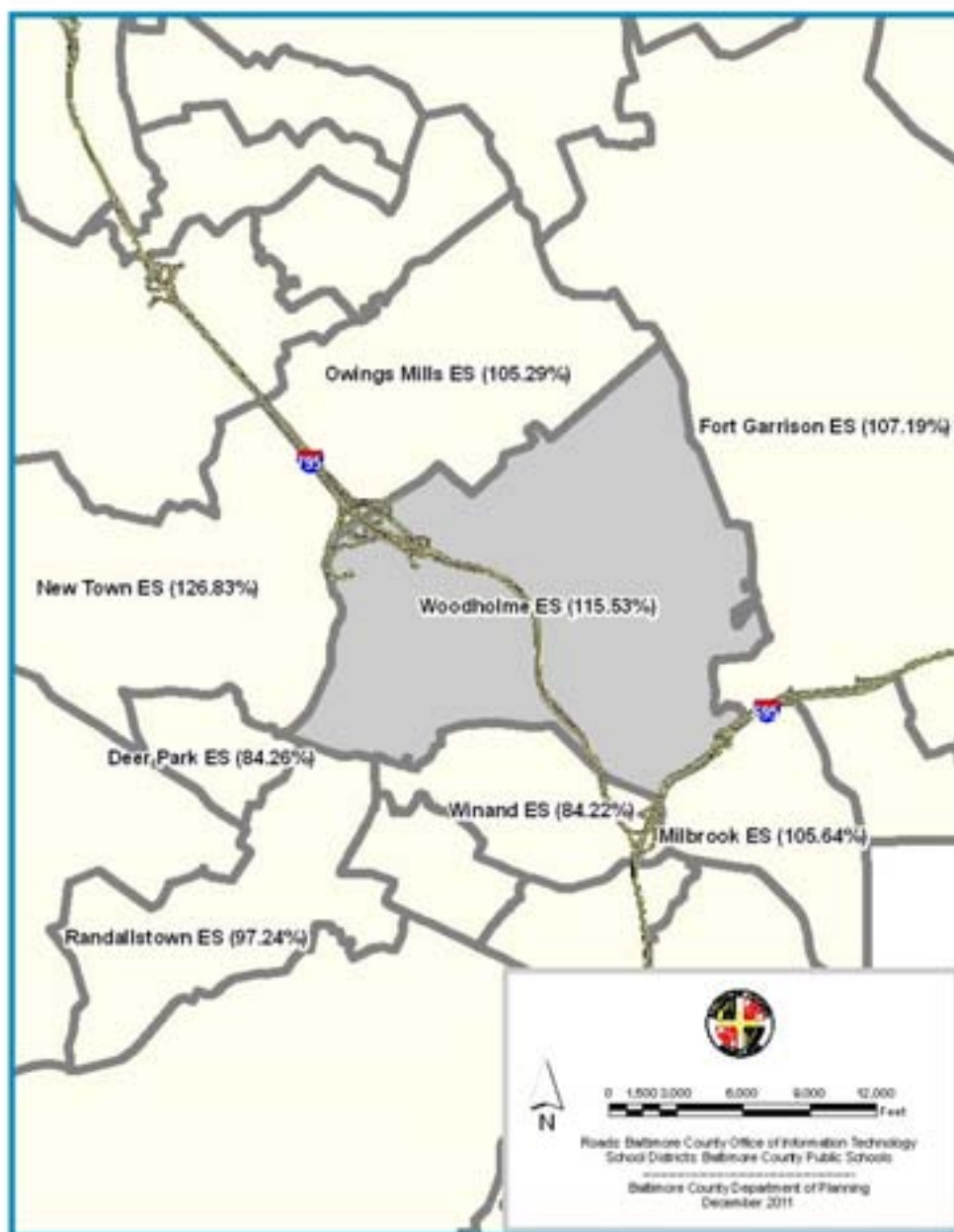
The West Towson Elementary School's enrollment of September 30, 2011 is 519. The State Rated Capacity (SRC) for this school is 451. Based on these numbers, West Towson Elementary School was 115.08% of SRC (See Appendix). A school impact analysis will be performed for each proposed development project to determine whether a school adjacent to West Towson Elementary School (see map above) is overcrowded under Section 32-6-103(f) of the Baltimore County Code. The Baltimore County FY 2012 Capital Budget has \$10,000,000 funded to construct a 300-seat addition at Hampton Elementary School and to design an addition at Stoneleigh Elementary School to address overcrowding conditions along the York Road corridor. The capacity needs for West Towson Elementary School will be examined pending a review of seats needed and overcrowding alternatives by the Baltimore County Public Schools.

## Westchester Elementary School



The Westchester Elementary School's enrollment of September 30, 2011 is 578. The State Rated Capacity (SRC) for this school is 499. Based on these numbers, Westchester Elementary School was 115.83% of SRC (See Appendix). A school impact analysis will be performed for each proposed development project to determine whether a school adjacent to Westchester Elementary School (see map above) is overcrowded under Section 32-6-103(f) of the Baltimore County Code.

## Woodholme Elementary School



The Woodholme Elementary School's enrollment of September 30, 2011 is 781. The State Rated Capacity (SRC) for this school is 676. Based on these numbers, Woodholme Elementary School is 115.53% of SRC (See Appendix). A school impact analysis will be performed for each proposed development project to determine whether a school adjacent to Woodholme Elementary School (see map above) is overcrowded under Section 32-6-103(f) of the Baltimore County Code.
