Minutes of the February 7, 2013 meeting

Mr. Phillips moved to accept of the Minutes of the February 7, 2013 meeting as circulated. Mr. Polek seconded the Motion, which unanimously passed at 4:49 p.m. Absent were Messrs. Gordon, Thompson, and Holupka.

Item for Discussion and Vote

1. 2013 Basic Services Maps

Mr. David Thomas, Assistant to the Director of Public Works, briefly summarized the issues identified on the 2013 Basic Services Maps for the Board. He also reiterated that the Department of Public Works is required to annually report on the Basic Services Maps, including Sewer Deficient Areas and Areas of Concern, Transportation Zones, and Water Supply Areas.

Mr. Thomas asked the Board to consider the issues and make a recommendation to the County Council to adopt the 2013 Basic Services Maps as drafted. Mr. Thomas noted that no citizens signed up to express concerns at the Public Comment Hearing held February 7, 2013.

Mr. Miller moved that the Planning Board recommend that the County Council adopt the 2013 Basic Services Maps for Public Water, Sewerage, and Transportation (signalized intersections), per the Memoranda as submitted by the Director of the Department of Public Works at the January 17, 2013 Planning Board meeting. Mr. Harvey Sr. seconded the motion.

In response to Mr. Miller's motion, Mr. Jenkins moved to amend the motion and 2013 Basic Services Transportation Map to reflect the Traffic Shed that was adopted by the County Council in 2012 for Joppa Road/ Loch Raven Boulevard. Ms. Hafford seconded the motion to amend, which unanimously passed at 4:53 p.m. Absent were Messrs. Gordon, Thompson, and Holupka.

Mr. Miller's original motion as amended was then called for a vote. The amended motion unanimously passed at 4:55 p.m. Absent were Messrs. Gordon, Thompson, and Holupka.
