SUBJECT: 2013 Basic Services Maps – Transportation: Final Report

Our bureau has restudied all of the intersections currently on the Basic Services Map for 2012 as well as continued the update of all other signalized intersections. Based on these studies over the past year, we are recommending the following changes to the Transportation Map for 2013:

ADDITIONS:	LEVEL-OF-SERVICE
York Rd(MD 45) and Timonium Rd	C to a D
Pulaski Hwy(US 40) and 66 <sup>th</sup> Street	C to a D
<u><b>DELETIONS:</b></u> Philadelphia Rd (MD 7) & Golden Ring Rd	D to a C
CHANGES: York Rd(Md 45) and Burke Ave	F to a E

Currently, there are three "F" intersections and one "E" level intersection that are being proposed on the 2013 Basic Services Transportation Map that would control development. Those intersections are:

F to a D

Loch Raven Blvd (MD 542) and E. Joppa Rd	LOS = F
Falls Rd (MD 25) and W. Seminary Ave (MD 131)	LOS = F
Frederick Rd (MD 144) and Bloomsbury Ave-Ingleside Ave	LOS = F
York Rd (MD 45) and Burke Ave	$rac{1}{1}$

For the past several years, the intersections of Md 45 and Timonium Rd and US 40 and 66<sup>th</sup> street have "teetered" on the LOS C/D threshold. Following numerous attempts by MdSHA to retime the traffic signals these intersections were observed to be operating at LOS D in the spring and fall of this year. Therefore, they were assigned the LOS D rating, which does not restrict development. The intersection of Md 45/Burke was also observed multiple times in 2012 and a LOS E was observed each time, therefore the LOS was changed from an F to E. The LOS E rating carries the same restrictions on development as the previous LOS F rating.

The intersection of Falls Rd(MD 25) and Joppa Rd was observed to be operating at a level of service "D". For the past few years, the "F" rating was the result of one of the approaches being overloaded in the PM peak hour thus resulting in the "F" rating for this intersection. We suspect the improved operation is due to a retiming of traffic signal resulting in the intersection's traffic flows being more balanced.

Commuter shed boundaries for the newly added LOS D intersections noted above have been developed and are shown on the 2013 Basic Service Map.
