Call to Order: 6:04 p.m. by President Bella Owens.

Women's Health: Phyllis Hall provided the commissioners with the following handouts:

Public Policy Agenda: Linda Forsyth reported that the January 31^{st} MLAW Agenda meeting was oversold. She also reported that SB 217 Criminal Law-Sexual Offenses-Physical Resistance was added and assigned to judicial proceedings. HB 1-MD Healthy Working Family Act status is in the house.

Sheila Derman provided MLAW's Legislative Agenda 2017 picks:

Women's Equality/Diversity: Ruth Howard reported that the Equality and Diversity Committee has shifted their direction from a "Tea and Talk" to a more inclusive event in late September, early October focusing on "Successful Women who have been Challenged due to Diversity Dimensions (Culture, Race, Religion, and Sexual Orientation)". The suggested format would include a panel of five from various backgrounds: government, healthcare, finance, legal, and community service and 75 participants. The panel will be led by a moderator (Ruth Howard). After the panel discussion the group will breakout into several sessions and present the findings from the sessions over a light lunch. The Committee would like to use this event as a pilot for a future 2017 Conference.

Woman of the Year 2017: Due to a conflict in the County Executive's schedule the original event date was changed from March 9th to March 28th. Renee reported that the nominations were reviewed by the Nominating Committee just prior to the regular meeting and winners chosen. The winners will be notified next week. The commission will review future selection criteria to make the categories more equal.

Domestic Violence: Nitsa had no report.

Human Trafficking: Frances was happy to report that Goucher will hold a panel in the spring on Human Trafficking and is looking to the commission for speaker recommendations.

Task Force – Nancy reported that the Task Force would be best served under a county department. The task force group identified the Health Department as the best fit and met with Dr. Branch from the health department. The group will meet again soon with Dr. Branch, along with pertinent members from his staff, to discuss an outline and initial steps with goal being "education and awareness". Task Force reps would include people from both the public and private sectors.

GUEST PRESENTATION: Scott Shellenberger, Baltimore County State's Attorney State's Attorney Shellenberger provided the commissioners with its 2017 Anti-Drug Poster calendar and spoke to the commissioners about current human trafficking issues and developments in Baltimore County.
