Human Trafficking: Task Force – Nancy reported that the Women's Commission Task Force group met recently with assigned key staff from the Health Department. Groups from the health department are already doing specific jobs. An inventory of what is currently going on in the county will be conducted so that the commission can assist with the gaps. The Women's Commission is in partnership with the Health Department until additional grants/funding may become available in six months. The group will meet again in early April.

Domestic Violence: Nitsa reported the recent Police Chief reappointment to Police Chief Terry Sheridan and the CDC's "VetoViolence" online portal open forum on "teen dating violence prevention". Bella added that Baltimore County will now investigate ALL assaults.

Old Business/New Business: 40th year anniversary recognition will be included in the Woman of the Year awards ceremony. A proclamation has been requested to honor this milestone. Flavor Cupcakery is unable to supply a donation of a 40th anniversary cake or cupcakes, Carmen will check with Black & Gold Catering. Ruth will look into gathering historical women's commission data to further highlight the 40th anniversary.
