- Protect MD Health Care Act of 2019
- Protective Orders Relief Eligible Rape & Sexual Offense
- State Government Discrimination in Employment Pregnancy & Childbirth
- Expansion of MD's Vacatur Law for Survivors of Human Trafficking

She will provide a report on what's introduced at the next meeting.
