6	Article 12. Animals, of the Baltimore County Code, 2003, as amended, to read as follows:

8	(AA) "RESEARCH INSTITUTE" HAS THE MEANING STATED IN § 101 OF THE
9	BALTIMORE COUNTY ZONING REGULATIONS.
10	SECTION 3. BE IT FURTHER ENACTED, that Sections 12-2-201(b) and 12-7-101(a),
11	of Article 12. Animals of the Baltimore County Code, 2003, as amended, are hereby repealed
12	and reenacted, with amendments, to read as follows:

14	(b) This section does not apply to a dog or cat included as part of:
15	(1) A commercial kennel, fancier kennel or cattery, or pet shop;
16	(2) A research [facility] INSTITUTE where bona fide medical or related
17	dental, veterinarian, pharmaceutical, or biological research is being conducted; or
18	(3) Any animal shelter operated by the state or local government, or which is
19	licensed by federal law or which is excluded from holding facility licensing requirements of this

7	446.1 DEFINITION. IN THIS SECTION, THE FOLLOWING WORD HAS THE MEANING
8	INDICATED.
9	WILD ANIMAL - HAS THE MEANING STATED IN ARTICLE 12 OF THE BALTIMORE
10	COUNTY CODE.
11	446.2 NOTWITHSTANDING ANY OTHER PROVISION OF THESE REGULATIONS, A
12	PERSON MAY NOT KEEP OR ALLOW TO BE KEPT ON THE PERSON'S PREMISES A
13	WILD ANIMAL EXCEPT AS PROVIDED IN ARTICLE 12, TITLE 7 OF THE BALTIMORE
14	COUNTY CODE.

15 SECTION 5. AND BE IT FURTHER ENACTED, that this Act, having been passed by

16 the affirmative vote of five members of the County Council, shall take effect on March 30, 2008.
