**Funeral Homes** 

FOR the purpose of permitting a funeral home to be located in an R.C. 6 Zone under certain conditions; exempting cemeteries and funeral homes from certain provisions of the R.C. 6 Zone; providing parking requirements for a funeral home; and generally relating to the requirements for funeral homes and cemeteries in the R.C. 6 Zone.
