FOR the purpose of amending the 2008-2009 Current Expense Budget, by appropriating to the

Gifts and Grants Special Revenue Fund monies derived from State funds and made available

to the County through the Maryland Department of Business and Economic Development.

WHEREAS, the Maryland Department of Business and Economic Development has

made an award of state funds available to the Baltimore County Department of Economic

Development to be used for improvements to the leased space that ViPS, Inc. is leasing in

the Towson Commons Building (The ViPS, Inc. Project); and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County

Charter and Section 10-6-102 of the Baltimore County Code, 2003, as amended, the County
