Revenue Authority - Multi-space parking meters

FOR the purpose of authorizing the Baltimore County Revenue Authority to replace single-space parking meters with multi-space parking meters under certain circumstances; providing specific requirements for multi-space parking meters; authorizing payment for parking by credit card and bills; providing for enforcement of parking meters; authorizing the traffic engineer to make certain determinations; altering the Towson parking meter district; and generally relating to the use of multi-space parking meters.

3	306(b), <u>18-2-307(b)</u> , 18-2-309(a) <u>and (c)</u> , 18-2-310, and 18-2-311 of Article 18. Transportation,
4	Title 2. Vehicles and Traffic, Subtitle 3. Parking Meters, of the Baltimore County Code, 2003, as
5	amended, are hereby repealed and reenacted, with amendments, to read as follows:

7	(d) "Parking meter" means a [coin-operated automatic or mechanical] device or meter
8	placed or erected for the regulation of parking.
9	(f) "Parking meter space" means a space within a parking meter [zone,] ZONE
10	THAT IS EITHER adjacent to a SINGLE-SPACE parking [meter, which is] METER OR
11	designated by lines painted on the surface of the street OR ADJACENT CURB OR SIDEWALK
12	for the parking of a single vehicle METER.

14	(a) The county Revenue Authority shall install <u>SINGLE-SPACE AND MULTI-</u>
15	SPACE parking meters in the parking meter zones [on the curb immediately adjacent to each
16	designated parking meter space] AND, AS APPLICABLE, ADJACENT TO PARKING METER
17	SPACES, as determined and designated in accordance with the applicable provisions of this
18	subtitle.

7	(a) At any time when any revenue bonds or mortgages issued by the county Revenue				
8	Authority for the purpose of financing the construction, acquisition, and improvement of				
9	off-street parking facilities in the county are outstanding and unpaid, the county may not:				
10	(1) (I) Reduce the total number of on-street SINGLE-SPACE parking meters				
11	installed on the streets of the county as of the date the bonds were issued; or				
12	(II) REDUCE THE SIZE OF OR ELIMINATE A PARKING				
13	METER ZONE ESTABLISHED AS OF THE DATE THE BONDS WERE ISSUED, IF THE				
14	COUNTY REPLACES SINGLE-SPACE PARKING METERS WITH MULTI-SPACE				
15	PARKING METERS; OR				
16	(2) Reduce the rates charged for the use of parking meters as of the date the				
17	bonds were issued.

3	a clockwise direction starting at the intersection of York Road and Burke Avenue, proceeding
4	[west along the south property line of Burke Avenue] SOUTH ALONG THE EAST

13	meter space] PLATE OR DEVICE REQUIRED UNDER § 18-2-304(D) OF THIS SUBTITLE
14	and which may be secured by [the deposit of one or more coins] PAYMENT into the parking
15	meter on a single occasion.
16	(2)(i) On the expiration of the maximum period, the operator shall remove the
17	vehicle from the parking meter space OR A PARKING METER ZONE CONTROLLED BY A
18	MULTI-SPACE PARKING METER, AS APPLICABLE.
19	(ii) The operator may not extend the maximum period by the deposit
20	of additional [coins] PAYMENT.
21	(C) A VEHICLE PARKED IN A PARKING METER SPACE OR A PARKING METER
