The 2008-2009 Current Expense Budget Gifts and Grants Special Revenue Fund Mobile Crisis Team Expansion

FOR the purpose of amending the 2008-2009 Current Expense Budget, by appropriating to the

Gifts and Grants Special Revenue Fund monies derived from the Harry and Jeanette

Weinberg Foundation made available to the County through the Affiliated Sante' Group.

WHEREAS, the Harry and Jeanette Weinberg Foundation has made an award of funds available to the Affiliated Sante' Group to be used for the expansion of the Mobile Crisis Team to the western part of Baltimore County, and that entity in turn has made an award of funds to be used by the Police Department for salary and benefits for four additional officers, two vehicles, office furnishings and computers; and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2003, as amended, the County

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

1	SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
2	COUNTY, MARYLAND, pursuant to the power and authority conferred upon it by Sections 306
3	and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County
4	Code, 2003, as amended, that the Current Expense Budget for the fiscal year ending June 30,
5	2009, be and is hereby amended by appropriating state funds made available from the Harry and
6	Jeanette Weinberg Foundation through the Affiliated Sante' Group to the Baltimore County
7	Police Department, in the amount herein specified, to the following program:
