ENTITLED

AN ACT concerning

Final Historical Landmarks List

FOR the purpose of adding new landmarks to the Final Historical Landmarks List; and generally relating to the Baltimore County Historical Landmarks List.

WHEREAS, the Landmarks Preservation Commission has met and compiled a preliminary list of additional structures to be added to the Final Historical Landmarks List; and

WHEREAS, the following structures have been identified on the preliminary landmarks list by the Commission and have been review by the County Executive; and

WHEREAS, a public hearing was held by the County Council on July 7, 2008 to determine which structures should be included on the “final landmarks list”; and

WHEREAS, the County Council finds that the following structures contribute substantially to the architectural and historical heritage of the county, state, or nation; now therefore

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
2 COUNTY, MARYLAND that new items 352 through 363 inclusive, be and they are hereby

Final Historical Landmarks List

The following historical landmarks are hereby adopted as part of the Final Historical Landmarks List:

- (352) Loch Raven Elementary School and setting, 1801 Glen Keith Boulevard, Parkville
- (353) Williams House and setting, 408 Virginia Avenue, East Towson
- (354) Jones House (I) and setting, 406 Virginia Avenue, East Towson
- (355) Hettinger Residence and setting, 1401 Clark Avenue, Lutherville
- (356) Gays Good Fellowship, house, summer kitchen, smokehouse and setting, 2000 Cromwell Bridge Road, Towson vicinity
- (357) Weisbrod-Carroll House and setting, 305 North Avenue, Lutherville
- (358) "Inwood" House and setting, 311 West Seminary Avenue, Lutherville
- (359) "Corkran House" and setting, 215 Lincoln Avenue, Lutherville
- (360) "Middletown Lodge #92, I.O.O.F. Building" and setting, 20220 Middletown Road, Middletown
- (361) "Lystra Meadows", (Barn and corn crib on Levi property) and setting, 10808 Greenspring Avenue, Brooklandville vicinity
- (362) Greenspring Punch Stone House and setting, 2031 Greenspring Valley Road, Brooklandville vicinity
- (363) Mt. Zion AME Church Parsonage and setting, 12800 Kaness Road, Glen Arm

SECTION 2. AND BE IT FURTHER ENACTED, that this Final Historical Landmarks List shall be maintained by the Landmarks Preservation Commission as provided in Section 32-7-106 of the Baltimore County Code, 2003, as amended.

SECTION 3. AND BE IT FURTHER ENACTED, that this Act, having been passed by the affirmative vote of five members of the County Council, shall take effect on September 15, 2008.
