FOR the purpose of authorizing the County Administrative Officer to recommend the conveyance of an easement over county property; providing for notification to the County Council without publication under certain circumstances; providing for payment for an easement; authorizing the conveyance of a certain easement for no compensation; defining a certain term; and generally relating to the conveyance of an easement over county property.
