The 2008-2009 Current Expense Budget Gifts and Grants Special Revenue Fund Community Access Ramp Program

FOR the purpose of amending the 2008-2009 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from private funds and made available to the County through The Harry and Jeanette Weinberg Foundation, Inc.

WHEREAS, The Harry and Jeanette Weinberg Foundation has made an award of private funds available to the Baltimore County Department of Aging, to be used to establish a program to provide exterior entrance ramps to low-income, disabled Baltimore County seniors in order to expand home accessibility, independence, safety, and support aging-inplace modification; and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2003, as amended, the County <u>Council may accept gifts and grants, appropriate same to the Gifts and Grants Special</u> EXPLANATION: <u>CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.</u> [Bracketcl indicate matter stricken from existing law]

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

1	SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
2	COUNTY, MARYLAND, pursuant to the power and authority conferred upon it by Sections
3	306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore
4	County Code, 2003, as amended, that the Current Expense Budget for the fiscal year ending
5	June 30, 2009, be and is hereby amended by appropriating private funds made available to
6	the Baltimore County Department of Aging, in the amount herein specified, to the following
