A BILL  
ENTITLED

AN ACT concerning

The 2008-2009 Current Expense Budget  
Gifts and Grants Special Revenue Fund  
2009 Presidential Inauguration Detail Grant

FOR the purpose of amending the 2008-2009 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from federal funds and made available to the County from the federal government through the Metropolitan Police Department.

WHEREAS, the Metropolitan Police Department, United States Attorney for the District of Columbia, the Baltimore County Police Department and Baltimore County Government have entered into a Memorandum of Understanding whereby in return for a promise of full reimbursement of all associated expenses, the Baltimore County Police Department has agreed to provide a total of 53 sworn personnel to assist with the Presidential Inauguration detail.

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2003, as amended, the County Council may accept gifts and grants, appropriate same to the Gifts and Grants Special Revenue Fund and expend the same, said fund having been established solely for the purpose of accounting for certain monetary gifts and grants made available to the County for restricted purposes; and

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

1           SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE  
2           COUNTY, MARYLAND, pursuant to the power and authority conferred upon it by Sections  
3           306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore  
4           County Code, 2003, as amended, that the Current Expense Budget for the fiscal year ending  
5           June 30, 2009, be and is hereby amended by appropriating federal funds made available  
6           through a grant from the Metropolitan Police Department to the Baltimore County Police  
7           Department in the amount herein specified to the following program:

8                   005-015-0953           Presidential Inauguration Detail Grant           \$98,000.00

9           SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed  
10          by the affirmative vote of five members of the County Council, shall take effect on  
11          December 29, 2008.
