AN ACT concerning

Newspaper Vending Boxes

FOR the purpose of regulating the placement and location of newspaper vending boxes; defining

terms; requiring a permit for each box; providing for the cost and term of a permit; providing

standards for the size, condition and maintenance of boxes; providing for the permitted

location of boxes and the grouping of boxes; providing for enforcement of the title; and

generally relating to newspaper vending boxes.

By adding

Sections 21-19-101 to 21-19-106 Article 21 - Permits, Licenses, and Business Regulation Title 19 - Newspaper Vending Boxes Baltimore County Code, 2003

1 21-19-102. PERMIT REQUIRED.

A PERSON MAY NOT PLACE, INSTALL, USE, OR MAINTAIN A NEWSPAPER VENDING
BOX ON A SIDEWALK WITHOUT HAVING OBTAINED AN ANNUAL PERMIT FROM THE
DEPARTMENT.

5 21-19-103. PERMIT APPLICATION; FEE; TERM.

6 (A) AN APPLICANT FOR A PERMIT SHALL FILE WITH THE DEPARTMENT AN

7 APPLICATION THAT CONTAINS THE FOLLOWING INFORMATION:

8 (1) THE NAME AND ADDRESS OF EACH DISTRIBUTOR;

9 (2) THE NAME AND ADDRESS OF ANY PERSON, OTHER THAN THE 10 DISTRIBUTOR, RESPONSIBLE FOR THE MAINTENANCE OF A NEWSPAPER VENDING 11 BOX; AND

12 (3) THE PROPOSED LOCATION OF EACH NEWSPAPER VENDING BOX.

13 (B) THE COST OF A PERMIT FOR EACH NEWSPAPER VENDING BOX IS \$50. A PERMIT

14 IS VALID FOR ONE YEAR.

15 21-19-104. STANDARDS FOR VENDING BOXES.

16 (A) DIMENSIONS. A NEWSPAPER VENDING BOX MAY NOT EXCEED 60 INCHES IN

17 HEIGHT, 30 INCHES IN WIDTH AND 24 INCHES IN DEPTH.

18 (B) COIN-RETURN MECHANISM REQUIRED.

A NEWSPAPER VENDING BOX SHALL BE EQUIPPED WITH A COIN-RETURN
 MECHANISM TO PERMIT A PERSON USING THE MACHINE TO SECURE IMMEDIATE

- 1 REFUND IF HE IS UNABLE TO RECEIVE THE PUBLICATION FOR WHICH HE HAS PAID.
- 2 THE COIN-RETURN SHALL BE MAINTAINED IN GOOD WORKING ORDER.
- 3 (C) POSTED NAME AND TELEPHONE NUMBER.
- 4 A NEWSPAPER VENDING BOX SHALL HAVE AFFIXED TO IT IN A READILY VISIBLE
- 5 PLACE, A NOTICE SETTING FORTH:
- 6 (1) THE NAME OF THE DISTRIBUTOR; AND
- 7 (2) THE TELEPHONE NUMBER TO CALL:

- 12 (1) A NEWSPAPER VENDING BOX SHALL BE MAINTAINED IN A NEAT AND
- 13 CLEAN CONDITION AND IN GOOD REPAIR AT ALL TIMES.
- 14 (2) A NEWSPAPER VENDING BOX SHALL BE SERVICED AND MAINTAINED SO15 THAT:
- 16 (I) IT IS REASONABLY FREE OF DIRT AND GREASE;
- 17 (II) IT IS REASONABLY FREE OF CHIPPED, FADED, PEELING, AND
 18 CRACKED PAINT IN VISIBLE, PAINTED AREAS;
- 19 (III) IT IS REASONABLY FREE OF RUST AND CORROSION IN VISIBLE,
 20 UNPAINTED METAL AREAS;
- (IV) THE CLEAR PLASTIC OR GLASS PARTS, IF ANY, THROUGH WHICH
 THE PUBLICATIONS ARE VIEWED ARE UNBROKEN AND REASONABLY FREE OF

- 2 (V) THE STRUCTURAL PARTS ARE IN GOOD REPAIR.
- 3 21-19-105. LOCATION OF VENDING BOXES.
- 4 (A) A NEWSPAPER VENDING BOX MAY NOT BE PLACED OR LOCATED IN OR ON ANY
- 5 PUBLIC PROPERTY OTHER THAN A SIDEWALK.
- 6 (B) A NEWSPAPER VENDING BOX MAY NOT BE PLACED, INSTALLED, USED, OR
- 7 MAINTAINED:
- 8 (1) WITHIN 6 FEET OF ANY MARKED CROSSWALK;
- 9 (2) WITHIN ANY DESIGNATED BUS STOP ALONG A SIDEWALK;
- 10 (3) WITHIN 6 FEET OF ANY FIRE HYDRANT OR 6 FEET FROM THE FRONT OF
- 11 ANY FIRE CALL BOX, POLICE CALL BOX, OR OTHER EMERGENCY FACILITY;
- 12 (4) WITHIN 3 FEET OF ANY DRIVEWAY; OR
- 13 (5) AT ANY LOCATION WHERE THE CLEAR SPACE FOR THE PASSAGEWAY OF
- 14 PEDESTRIANS IS REDUCED TO LESS THAN 4 FEET.
- 15 (C) (1) A NEWSPAPER VENDING BOX SHALL BE LOCATED ONLY:
- 16 (I) ON OR NEAR THE SIDEWALK OR, IF THERE IS NO SIDEWALK, THE
- 17 EDGE OF THE PUBLIC RIGHT-OF-WAY; OR
- 18 (II) ALONG A BUILDING, WALL, OR OTHER STRUCTURE.
- (2) A NEWSPAPER VENDING BOX LOCATED ON OR NEAR THE SIDEWALK
 SHALL BE LOCATED NO LESS THAN 12 INCHES NOR MORE THAN 24 INCHES FROM
 THE ROADWAY EDGE OF THE SIDEWALK.

(3) A NEWSPAPER VENDING BOX LOCATED ADJACENT TO A BUILDING, WALL,
 OR OTHER STRUCTURE SHALL BE LOCATED PARALLEL TO AND NOT MORE THAN 6
 INCHES FROM THE WALL.

4 (D) (1) NEWSPAPER VENDING BOXES MAY BE PLACED NEXT TO EACH OTHER,
5 BUT NO MORE THAN THREE BOXES MAY BE PLACED OR LOCATED IN ONE
6 GROUPING OF BOXES.

7 (2) A GROUPING OF NEWSPAPER VENDING BOXES SHALL BE LOCATED AT
8 LEAST 200 FEET FROM ANY OTHER GROUPING OF BOXES.

9 (E) (1) A NEWSPAPER VENDING BOX MAY BE FREE-STANDING OR MAY BE
10 ATTACHED TO ANY SIDEWALK BY BOLTS OR OTHER DEVICES.

(2) UPON REMOVAL OF ANY BOX, ANY BOLT HOLES OR OTHER DAMAGE TO
 THE SIDEWALK SHALL BE REPAIRED BY THE DISTRIBUTOR WHOSE NEWSPAPER
 VENDING BOX CAUSED THE HOLES OR DAMAGE.

14 21-19-106. ENFORCEMENT.

15 (A) THE DEPARTMENT SHALL ENFORCE THE PROVISIONS OF THIS TITLE IN
16 ACCORDANCE WITH ARTICLE 3, TITLE 6 OF THE CODE.

17 (B) (1) IF THE DEPARTMENT DOES NOT RENEW A PERMIT, THE DISTRIBUTOR SHALL

18 REMOVE THE NEWSPAPER VENDING BOX WITHIN 30 DAYS AFTER RECEIPT OF

19 NOTICE THAT THE PERMIT HAS NOT BEEN RENEWED.

20 (2) IF THE DEPARTMENT DETERMINES THAT A NEWSPAPER VENDING BOX HAS
21 BEEN INSTALLED, USED, OR MAINTAINED IN VIOLATION OF ANY OF THE

PROVISIONS OF THIS TITLE, THE DEPARTMENT MAY ISSUE A CORRECTION NOTICE
 TO THE DISTRIBUTOR TO CORRECT THE CONDITION.

3 (3) IF, WITHIN 5 DAYS AFTER RECEIPT OF THE CORRECTION NOTICE, THE
4 DISTRIBUTOR FAILS TO CORRECT THE CONDITION OR REQUEST A HEARING, THE
5 DEPARTMENT MAY REMOVE THE NEWSPAPER VENDING BOX AND PROCESS IT AS
6 ABANDONED PROPERTY.

7 SECTION 2. AND BE IT FURTHER ENACTED, that this Act shall take effect 45 days after its enactment.
