A BILL ENTITLED

AN ACT concerning

Pet Cemeteries

FOR the purpose of requiring the owner of a pet cemetery to maintain certain records and to maintain the grounds of a pet cemetery; defining terms; specifying the duties of the owner of a pet cemetery; providing penalties; and generally relating to the regulation of pet cemeteries.

BY adding

Sections 21-19-101 to 21-19-105 Article 21 - Permits, Licenses, and Business Regulations Title 19 - Pet Cemeteries Baltimore County Code 2003

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE

- 14 (D) "PET" MEANS A DOMESTIC ANIMAL THAT HAS BEEN ADAPTED OR TAMED TO
- 15 LIVE WITH PEOPLE.
- 16 (E) (1) "PET CEMETERY" MEANS ANY LAND, PLACE, STRUCTURE, FACILITY, OR
- 17 BUILDING PROVIDED BY A PERSON FOR THE PERMANENT INTERMENT OR
- 18 INURNMENT OF PET REMAINS OR CREMATED PET REMAINS FOR A FEE.
- 19 (2) PET CEMETERY" DOES NOT INCLUDE A LANDFILL OR SOLID WASTE20 DISPOSAL FACILITY.
- 21 (F) (1) "PET OWNER" MEANS A PERSON LISTED AS THE OWNER OF A PET ON THE
 22 RECORDS OF A PET CEMETERY.
- 23 (2) "PET OWNER" INCLUDES THE AGENT OF A PET OWNER.

3 (1) MAPS AND RECORDS OF THE SPECIFIC SITES OF EACH PET GRAVE OR
4 UNUSED BURIAL LOT;

- 6 (3) THE DATE OF INTERNMENT OR INURNMENT;
- 7 (4) THE SIZE OF EACH GRAVE OR BURIAL LOT;
- 8 (5) THE CONTRACT FOR THE INTERMENT OR INURNMENT OF EACH PET; AND
- 9 (6) THE CONTRACT FOR THE PURCHASE OF EACH UNUSED BURIAL LOT.

10 (B) AN OWNER OF A PET CEMETERY SHALL KEEP DUPLICATE RECORDS OF ALL

11 RECORDS DESCRIBED UNDER SUBSECTION (A) OF THIS SECTION AT A LOCATION

14 (A) (1) AN OWNER OF A PET CEMETERY SHALL ENSURE THE THOROUGH AND
15 REGULAR MAINTENANCE OF THE PET CEMETERY GROUNDS AND THE GRAVE OR
16 BURIAL LOTS.

17 (2) ANY SIDEWALKS, PATHS, OR WALKWAYS SHALL BE SAFELY18 CONSTRUCTED AND MAINTAINED.

(B) AN OWNER OF A PET CEMETERY SHALL MAINTAIN CLEAN AND REFRIGERATED
HOLDING FACILITIES FOR THE SAFE STORAGE OF DECEASED PETS.

2 (A) THE DEPARTMENT MAY INSTITUTE ANY ACTION AT LAW OR EQUITY,
3 INCLUDING INJUNCTION OR MANDAMUS, TO ENFORCE THE PROVISIONS OF THIS
