ENTITLED

AN ACT concerning

B.L. Zone - Bakery

FOR the purpose of permitting wholesale bakery operations in the B.L. Zone under certain conditions; and generally relating to permitted uses in the B.L. Zone.

By repealing and re-enacting, with amendments

Section 230.1.A.9

Baltimore County Zoning Regulations, as amended

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE COUNTY,
2 MARYLAND, that Section 230.1.A.9 of the Baltimore County Zoning Regulations, as amended, be
3 and it is hereby repealed and re-enacted, with amendments, to read as follows:

1 SECTION 230, Business, Local (B.L.) Zone Use Regulations

2 § 230.1 Permitted uses.

3 A. The following uses only are permitted (See Section 230.2.):

4 9. Alcoholic beverage package store

5 Amusement devices, subject to the provisions of Section 422

6 Animal grooming facility

7 Antique shop

8 Arcade, subject to the provisions of Section 423. A

9 Automobile accessory shop

10 Automobile parking lot

11 Bakery, but goods baked on the premises must be sold only at retail on the premises,
12 EXCEPT THAT WHOLESALE OPERATIONS ARE PERMITTED IF THE BAKERY IS
13 LOCATED IN A COMMERCIAL REVITALIZATION DISTRICT AND IF THE RETAIL
14 COMPONENT OF THE BAKERY FRONTS THE STREET AND THE WHOLESALE
15 OPERATIONS ARE LIMITED TO NO MORE THAN 30% OF THE BUILDING'S
16 SQUARE FOOTAGE

17 Barbershops and beauty shops

18 Billiard and pool rooms

19 Bowling alley

20 Camera, photo-supply or film-processing shops or pickup stations (including "drive-by"
21 facilities)

22 Candy store, but goods made on the premises must be sold only at retail on the premises

23 Clothing and accessory stores

24 Commercial film production, subject to Section 435

27 Dressmaking and millinery establishments

28 Drugstore

29 Dry-cleaning establishment, coin-operated, or retail store plant, etc. (as regulated by the

33 Electrical contractors and appliance repair shop

1 Tailor shop

5 Temporary or occasional outdoor sales of cut flowers or live plants (not in connection with
6 florists' establishments), provided that the sales area does not exceed 200 square feet and
7 that the sales are carried on for no more than 120 days per year. Before approving an
8 application for any license required, the Zoning Commissioner must approve a site plan for
9 the premises, showing the sales area and the dates on which flowers or plants are to be sold.
10 Any provision of these regulations to the contrary notwithstanding, the Zoning
11 Commissioner's approval of such a license shall expire one year after its issuance; however,
12 such a license may be reapproved annually upon request of the licensee

19 SECTION 2. AND BE IT FURTHER ENACTED, that this Act shall take effect forty-five days
20 after its enactment.
