## AN ACT concerning

Zoning Regulations - Domestic Animal Sanctuaries

FOR the purpose of defining domestic animal sanctuary and permitting a domestic animal sanctuary in the R.C. 2 Zone; and generally relating to domestic animal sanctuaries in R.C. 2 Zones. By adding

Section 101.1 (Definition of "Domestic Animal Sanctuary") Baltimore County Zoning Regulations, as amended

SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
COUNTY, MARYLAND, that Section 101.1. (Definition of "Domestic Animal Sanctuary") and
1A01.2.B.14 and Section 421.8 be and they are hereby added to the Baltimore County Zoning
Regulations, as amended, to read as follows:
