A BILL ENTITLED

AN ACT concerning

The 2010-2011 Current Expense Budget Gifts and Grants Special Revenue Fund American Recovery and Reinvestment Act Workforce Investment Act Program

FOR the purpose of amending the 2010-2011 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from federal funds and made available to the County through the Maryland Department of Labor, Licensing and Regulation.

WHEREAS, the Maryland Department of Labor, Licensing and Regulation has made an award of federal funds available to the Baltimore County Office of Workforce Development, to be used for employment and training activities; and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2003, as amended, the County Council may accept gifts and grants, appropriate same to the Gifts and Grants Special Revenue Fund and expend

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
COUNTY, MARYLAND, pursuant to the power and authority conferred upon it by Sections 306
and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code,
2003, as amended, that the Current Expense Budget for the fiscal year ending June 30, 2011, be and
is hereby amended by appropriating federal funds made available to the Baltimore County Office
of Workforce Development, in the amount herein specified, to the following program:
