A BILL  
ENTITLED

AN ACT concerning

The 2010-2011 Current Expense Budget  
Gifts and Grants Special Revenue Fund  
Cigarette Restitution Fund - Cancer Grant

FOR the purpose of amending the 2010-2011 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from the Cigarette Restitution Fund and made available to the County through the State of Maryland Department of Health and Mental Hygiene.

WHEREAS, the State of Maryland Department of Health and Mental Hygiene has made an award of Cigarette Restitution Funds available to the Baltimore County Department of Health, to be used to fund additional staff and to provide approximately 40 colonoscopies for low-income Baltimore County citizens; and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2003, as amended, the County Council may

accept gifts and grants, appropriate same to the Gifts and Grants Special Revenue Fund and expend the same, said fund having been established solely for the purpose of accounting for certain monetary gifts and grants made available to the County for restricted purposes; and

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

1           SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE  
2 COUNTY, MARYLAND, pursuant to the power and authority conferred upon it by Sections 306  
3 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code,  
4 2003, as amended, that the Current Expense Budget for the fiscal year ending June 30, 2011, be and  
5 is hereby amended by appropriating Cigarette Restitution Funds made available to the Baltimore  
6 County Department of Health, in the amount herein specified, to the following program:

7           005-030-1124           Cigarette Restitution Fund - Cancer Grant     \$130,418

8           SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed by the  
9 affirmative vote of five members of the County Council, shall take effect November 28, 2010.
