## A BILL ENTITLED

AN ACT concerning

The 2011-2012 Current Expense Budget Gifts and Grants Special Revenue Fund Animal Control Endowment

FOR the purpose of amending the 2011-2012 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from private funds made and available to the County through the Estate of the late Audrey R. Dix and community donations.

WHEREAS, the estate of Audrey R. Dix has made a donation of \$17,000 and another

\$5,460 in private funds have been made available to the Baltimore County Department of Health

through community donations, to be used to make improvements to the animal shelter equipment

and facilities for the benefit of the animals; and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2003, as amended, the County Council may accept gifts and grants, appropriate same to the Gifts and Grants Special Revenue Fund and expend the same, said fund having been established solely for the purpose of accounting for certain monetary gifts and grants made available to the County for restricted purposes; and

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore
