## A BILL ENTITLED

AN ACT concerning

The 2012-2013 Current Expense Budget Gifts and Grants Special Revenue Fund Recovery Support Services Expansion

FOR the purpose of amending the 2012-2013 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from state funds and made available to the County through the Department of Heath and Mental Hygiene, Alcohol and Drug Abuse Administration.

WHEREAS, the Department of Heath and Mental Hygiene, Alcohol and Drug Abuse

Administration, has made an award of state funds available to the Baltimore County Department

of Health, to be used to expand an existing recovery community center, establish an additional

recovery community center provider, and provide funds to our existing outpatient substance

abuse providers to hire peer support specialist; and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2003, as amended, the County Council may accept gifts and grants, appropriate same to the Gifts and Grants Special Revenue Fund and expend the same, said fund having been established solely for the purpose of accounting for certain monetary gifts and grants made available to the County for restricted purposes; and

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE

and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Co	ode,
