- 3 259.11. Development standards for MD 43 Overlay District.
- 4 A. Uses permitted by right.
 - 3. Notwithstanding any of the regulations of this section to the contrary and in addition to the rights granted under this section, residential uses[, permitted and as limited in accordance with the BM-CT Zone,] are permitted to be built on a maximum 30% OF THE [of eight acres that are part of an overall tract of at least 800 acres under common ownership or control or part of a common scheme of development. [Such residential uses] MULTI-FAMILY UNITS ARE PERMITTED IN ACCORDANCE WITH THE REGULATIONS APPLICABLE TO THE BM-CT ZONE, EXCEPT THAT UNITS are permitted on any story of a proposed building. OTHER RESIDENTIAL UNIT TYPES ARE PERMITTED IN ACCORDANCE WITH THE BULK, HEIGHT, AND BUILDING SETBACK REQUIREMENTS APPLICABLE TO THE DR 10.5 ZONE.
