## A BILL ENTITLED

#### AN ACT CONCERNING

Employees' Retirement System - Nonforfeitability

FOR the purpose of clarifying that in the event of termination or partial termination of the Employees Retirement System, the rights of members and beneficiaries are nonforfeitable in conformance with federal law; providing for the retroactive effect of this Act; and generally relating to the Employees' Retirement System.

By repealing and reenacting without amendments

Section 5-1-201(g) and (o) and 5-1-202(a) Title 1. Employees Retirement System Article 5. Pensions and Retirement Baltimore County Code, 2003

### By adding

Section 5-1-202(d)
Title 1. Employees Retirement System
Article 5. Pensions and Retirement
Baltimore County Code, 2003

1	SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
2	COUNTY, MARYLAND, that the Laws of Baltimore County shall read as follows:
3	Article 5. Pensions and Retirement
4	§ 5-1-201.
5	(g) "Beneficiary" means any person in receipt of a pension, an annuity, a retirement
6	allowance, or other benefit as provided by this subtitle.
7	(o) "Member" means any employee included in the membership of the retirement
8	system as provided in § 5-1-203 of this subtitle.
9	§ 5-1-202.
10	(a) A retirement system is hereby established and placed under the management of
11	the Board of Trustees for the purpose of providing retirement allowances and other benefits
12	under the provisions of this title for employees. The Retirement System so created shall be
13	established as of January 1, 1945. It shall be known as the "Employees' Retirement System of
14	Baltimore County," and by such name all of its business shall be transacted, all of its funds
15	invested, and all of its cash and securities and other property held in trust for the purpose for
16	which received.
17	(D) IN ACCORDANCE WITH § 411 OF THE INTERNAL REVENUE CODE, IF THE
18	EMPLOYEES RETIREMENT SYSTEM IS TERMINATED OR PARTIALLY TERMINATED
19	THE RIGHTS OF ALL AFFECTED BENEFICIARIES AND MEMBERS ACCRUED UP TO
20	THE DATE OF TERMINATION OR PARTIAL TERMINATION, TO THE EXTENT
21	FUNDED AS OF THE DATE OF TERMINATION OR PARTIAL TERMINATION, OR THE

- 1 AMOUNTS CREDITED TO THE BENEFICIARIES' OR MEMBERS'S ACCOUNTS, ARE
- 2 NONFORFEITABLE.
- 3 SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having by passed by the
- 4 affirmative vote of five members of the County Council, shall take effect on October 20, 2013
- 5 retroactive to July 1, 2002.
