AN ACT concerning

Synthetic Cannabinoids

FOR the purpose of specifying the term synthetic cannabinoid in the prohibition on the distribution, use, purchase, or possession of certain synthetic products or compounds heretofore indicated as Spice or K-2; defining the terms synthetic cannabinoid and synthetic marijuana; amending the monetary penalty; providing for forfeiture of property; and generally relating to certain synthetic products or compounds.

1	SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
2	COUNTY, MARYLAND, that the Laws of Baltimore County read as follows:

4	§ 17-1-118. [SPICE] SYNTHETIC CANNABINOID.
5	(a) Definitions.
6	(1) As used in this section, the following words have the meanings indicated.
7	(2) "Distribute" means to:
8	(I) Give, sell, deliver, dispense, or issue; or
9	(ii) Offer to give, sell, deliver, dispense, or issue; or
10	(iii) Cause or hire any person to give, sell, deliver, dispense, or issue or offer
11	to give, sell, deliver, dispense, or issue.
12	(3) "[Spice] SYNTHETIC CANNABINOID" means a material, substance,
13	compound, mixture or preparation in any form that WOULD REASONABLY INDICATE UNDER
14	ALL CIRCUMSTANCES TO BE SYNTHETIC MARIJUANA, INCLUDING BUT NOT LIMITED
15	TO PRODUCTS [contains the compound JWH-018 or JWH-073 and is] known as Spice [or], K2,
16	SCOOBY SNAX, POTPOURRI, or any other name.
17	(4) "SYNTHETIC MARIJUANA" MEANS A PSYCHOACTIVE SUBSTANCE
18	OR COMPOUND CREATED WITH MAN-MADE SYNTHETIC CHEMICALS THAT, WHEN
19	CONSUMED OR INGESTED, MIMICS THE INTOXICATING EFFECTS OF MARIJUANA
20	THC, THE PSYCHOACTIVE INGREDIENT IN THE NATURALLY GROWN MARIJUANA
21	PLANT.
22	(b) Scope. This section does not apply to an accredited academic or medical institution or

1	research facility, or any authorized agent of such facilities, that conducts research on [Spice] A
2	SYNTHETIC CANNABINOID.
3	(C) Prohibition.
4	(1) A person may not purchase, use or possess [Spice] A SYNTHETIC
5	CANNABINOID.
6	(2) A person may not distribute a substance:
7	(I) That the person represents is [Spice] ANY FORM OF SYNTHETIC
8	CANNABINOID.
9	(ii) That the person intends for use or distribution as [Spice] A SYNTHETIC
10	CANNABINOID; or
11	(iii) Under circumstances that one reasonably should know that the substance
12	will be used or distributed for use as [Spice] A SYNTHETIC CANNABINOID.
13	(d) Penalty.
14	(1) A person who violates this section is guilty of a misdemeanor and on
15	conviction is subject to a fine of NOT EXCEEDING \$500 or imprisonment not exceeding 60 days
16	or both.
17	(2) PROPERTY SEIZED IN CONNECTION WITH ENFORCEMENT OF THIS
18	SECTION IS SUBJECT TO FORFEITURE IN ACCORDANCE WITH THE DRUG ASSET
19	FORFEITURE STATUTE SET FORTH IN SECTIONS 12-101 TO 12-505 OF THE CRIMINAL
20	PROCEDURE ARTICLE OF THE ANNOTATED CODE OF MARYLAND.
21	
22	SECTION 2. AND BE IT FURTHER ENACTED, that this Act shall take effect 45 days
23	from the date of its enactment.
