- SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
- 2 COUNTY, MARYLAND, that the Baltimore County Zoning Regulations read as follows:

Manufacturing, Heavy (M.H.) Zone Use Regulations

2	§ 256.1. Permitted Uses.
3	A. The following uses only are permitted, subject to the provisions of Subsection 256.3:
4	1. Uses permitted in M.R. Zone, Section 241.1 and in Section 253.4 of the M.L. Zone:
5	Animal boarding place, Class A
6	Animal boarding place, Class B
7	Animal grooming facility, subject to Section 421.
8	Boatyard
9	Brewery, Class 5B, if within the urban rural demarcation line
10	Car wash in a planned industrial park only, subject to Section 419
11	Commercial beach, with provision of adequate parking area, and permitting dressing
12	facilities, snack bar, picnic area and boat rental
13	Community building, swimming pool or other structural or land use devoted to civic,
14	social, recreational and educational activities
15	COMMERCIAL RECREATION ENTERPRISES, INCLUDING DANCE HALLS,
16	SKATING RINKS AND OTHERS WHICH, IN THE JUDGMENT OF THE ZONING
17	COMMISSIONER, ARE SIMILAR, BUT EXCLUDING MERRY-GO-ROUNDS AND FREAK
18	SHOWS, SHOOTING GALLERIES AND PENNY ARCADES. THE USE SHALL BE LOCATED
19	IN A BUILDING EXISTING ON THE EFFECTIVE DATE OF BILL 63-14, AND OPERATION
20	OF THE RECREATION USE SHALL BE ENTIRELY INSIDE THE BUILDING.
21	Fuel service station, in a planned industrial park only, subject to Section 405

1	Golf course, country club or other outdoor recreation clubs; also quasi-public camp,
2	including day camps, but no such uses shall be located on less than five acres, and no building.
3	parking lot or out-of-water marine craft storage thereon shall be located within 60 feet of any
4	residential property line
5	Living quarters for watchmen and caretakers and their families employed and living
6	on the premises, in connection with any lawful use in the M.H. zone

8	Storage of inflammable liquids and gases underground (For requirements see

17	affirmative vote of five members of the County Council, shall take effect on November 13, 2014.
