## A BILL ENTITLED

Distribution of Tobacco Products to Minors

FOR the purpose of amending certain penalties and enforcement provisions pertaining to the distribution of tobacco products to minors; and generally relating to the distribution of tobacco products to minors.

Baltimore County Code, 2003

SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE

COUNTY, MARYLAND, that the Laws of Baltimore County read as follows:

5	[(1) An owner who violates any provision of this title is subject to a civil penalty of \$300 for the
6	first violation and \$500 for any subsequent violations.

8	OF § 13-12-103 OF THIS TITLE OR THE PRODUCT PLACEMENT PROVISIONS OF § 13-12-
9	104 OF THIS TITLE IN ANY CALENDAR YEAR IS SUBJECT TO A CIVIL PENALTY AS
10	FOLLOWS:
11	(I) \$500 FOR A FIRST VIOLATION;
12	(II) \$1,000 FOR A SECOND VIOLATION; AND
13	(III) \$1,500 OR SUSPENSION OF ALL TOBACCO SALES FOR ONE MONTH OR BOTH
14	FOR A THIRD OR SUBSEQUENT VIOLATION.
15	(2) AN OWNER WHO VIOLATES THE IDENTIFICATION CHECK PROVISIONS OF § 13-
16	12-103.1 OF THIS TITLE IN ANY CALENDAR YEAR IS SUBJECT TO A WRITTEN
17	WARNING FOR A FIRST VIOLATION AND THEREAFTER A CIVIL PENALTY AS
18	FOLLOWS:
19	(I) \$100 FOR A SECOND VIOLATION; AND
20	(II) \$250 FOR A THIRD OR SUBSEQUENT VIOLATION.
21	(3) An owner is liable for violation of this title committed by an employee or agent of the owner
