## A BILL ENTITLED

#### AN ACT concerning

Zoning Regulations - Conservation Burial Ground

FOR the purpose of revising the conservation burial ground Regulation to require that additional conditions be met prior to the granting of a special exception; and generally relating to conservation burial grounds.

#### BY repealing and re-enacting, with amendments

Section 401.1.1.6 Baltimore County Zoning Regulations, as amended

BY adding

Sections 401.1.1.7 and .8 Baltimore County Zoning Regulations, as amended

19		PROPOSED WELLS AND SEPTIC SYSTEMS ON AND WITHIN 200
20		FEET OF THE PROPERTY LINE, AND EXISTING AND PROPOSED
21		STRUCTURES ON AND WITHIN 200 FEET OF THE PROPERTY LINE;

- 1B.A DETERMINATION OF THE DEPTH TO BEDROCK AND DEPTH2AND FLOW DIRECTION OF GROUNDWATER BENEATH THE AREA3PROPOSED AS A BURIAL GROUND; AND

  5 POTENTIAL IMPACTS OF BURIED REMAINS ON GROUNDWATER
  6 QUALITY, SURFACE WATER QUALITY, AND DOMESTIC WATER
  7 SUPPLIES IN RELATION TO HUMAN HEALTH AND THE
  8 ENVIRONMENT; AND
- 9 RECOMMENDATIONS AS TO THE APPROPRIATE NUMBER, AND D. 10 THE LOCATION AND PLACEMENT, OF BURIAL SITES ON THE 11 LAND BASED ON THE FINDINGS IN PARAGRAPHS A, B, AND C. 12 8. THE DIRECTOR OF THE DEPARTMENT OF ENVIRONMENTAL 13 PROTECTION AND SUSTAINABILITY SHALL ADOPT REGULATIONS TO 14 ADMINISTER AND ENFORCE THE PROVISIONS OF THIS SECTION, 15 INCLUDING BUT NOT LIMITED TO, CONSIDERATION OF HYDROLOGIC 16 ISSUES AND GENERAL HEALTH AND LIVABILITY ISSUES POTENTIAL 17 IMPACTS TO HUMAN HEALTH AND THE ENVIRONMENT RELATED TO A 18 CONSERVATION BURIAL GROUND.

SECTION 2. AND BE IT FURTHER ENACTED, that an application for a special exception
 under this section may not be accepted for filing, and a special exception may not be granted, until

- regulations governing the administration and enforcement of this section are promulgated and
   adopted by the Department of Environmental Protection and Sustainability.
- 3 SECTION 3. AND BE IT FURTHER ENACTED, that this Act, having been passed by the
  4 affirmative vote of five (5) members of the County Council, shall take effect on July 20, 2015.
