## A BILL ENTITLED

#### AN ACT concerning

The 2015-2016 Current Expense Budget Gifts and Grants Special Revenue Fund Breastfeeding Peer Counselor <del>WIC Supplementation Grant</del>

FOR the purpose of amending the 2015-2016 Current Expense Budget, by appropriating to the

Gifts and Grants Special Revenue Fund monies derived from federal funds from the U.S.

Department of Agriculture and made available to the County through the Maryland

Department of Health and Mental Hygiene.

WHEREAS, the Department of Health and Mental Hygiene has made an award of federal

funds available to the Baltimore County Department of Health and Human Services, to be used

for the salary and benefits for an additional outreach worker; and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County

Charter and Section 10-6-102 of the Baltimore County Code, 2003, as amended, the County

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE 1 COUNTY, MARYLAND, pursuant to the power and authority conferred upon it by Sections 306 2 3 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2003, as amended, that the Current Expense Budget for the fiscal year ending June 30, 4 5 2016, be and is hereby amended by appropriating federal funds made available to the Baltimore 6 County Department of Health and Human Services, in the amount herein specified, to the following program: 7
