A BILL  
ENTITLED

AN ACT concerning

Social Host – Unruly Social Gatherings – Pilot Program Area

FOR the purpose of amending the Pilot Program Area for Social Host – Unruly Social Gatherings to include additional areas of Greater Towson; amending a certain definition; and generally relating to the Pilot Program Area for Social Host – Unruly Social Gatherings.

BY repealing and re-enacting, with amendments  
Section 13-7-131(a) and (c) and 13-7-133(a)  
Article 13 - Public Health, Safety, and the Environment  
Title 7 - Nuisances  
Subtitle 1 - General Nuisances on Private Property and on Public Roads  
Part IV - Unruly Social Gatherings Pilot Program  
Baltimore County Code, 2015

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE  
2 COUNTY, MARYLAND, that the Laws of Baltimore County read as follows:

6 § 13-7-101. Definitions.

8 (a) In general. In this Part IV of this subtitle the following words have the meanings  
9 indicated.

11 (c) Alcoholic beverage. “Alcoholic beverage” has the meaning stated in § 1-101 OF THE  
12 ALCOHOLIC BEVERAGES Article [2B, § 1-102] of the Annotated Code of Maryland.

14 § 13-7-133. Issuance of Citation for Unruly Social Gatherings – Pilot Program.

15 (a) Pilot program area. The “pilot program area” for this Part IV of this subtitle means:

16 (1) The [area] AREAS of [East] GREATER Towson consisting of:

17 (I) [the] THE area OF EAST TOWSON CONSISTING OF THE AREA  
18 east of York Road, north and west of Stevenson Lane, south and west of Hillen Road, north of  
19 Eudowood Lane, east of Railroad Avenue, south of Pennsylvania Avenue, east of Virginia Avenue,  
20 and south of Towsontown Boulevard[.];

21 (II) THE AREA OF WEST TOWSON CONSISTING OF THE AREA  
22 SOUTH OF THE INTERSTATE 695 BELTWAY, WEST OF DULANEY VALLEY ROAD  
23 AND YORK ROAD, NORTH OF ALLEGHENY AVENUE, EAST OF BOSLEY AVENUE,  
24 NORTH OF WEST JOPPA ROAD NORTH OF TOWSONTOWN BOULEVARD, AND EAST  
25 OF NORTH CHARLES STREET;

1 (III) THE AREA OF THE RODGERS FORGE COMMUNITY  
2 CONSISTING OF THE RESIDENTIAL BOUNDARIES OF AND WITHIN STANMORE  
3 ROAD AND STANMORE COURT, STEVENSON LANE, YORK ROAD, OVERBROOK  
4 ROAD, DUNKIRK ROAD, BELLONA AVENUE, MURDOCK ROAD, REGESTER AVENUE,  
5 AND DUMBARTON ROAD; AND

6 (IV) THE AREA OF THE LOCH RAVEN VILLAGE AND  
7 KNETTISHALL COMMUNITIES CONSISTING OF THE RESIDENTIAL BOUNDARIES OF  
8 AND WITHIN JOPPA ROAD, PLEASANT PLAINS ROAD, MUSSULA ROAD AND  
9 MYAMBY ROAD TO LOCH RAVEN BOULEVARD, PUTTY HILL AVENUE TO LOCH  
10 RAVEN BOULEVARD TO LOCH NESS ROAD, PLEASANT PLAINS ROAD TO COTTAGE  
11 LANE TO LOCH RAVEN BOULEVARD, GLEN KEITH BOULEVARD, ABERDEEN ROAD,  
12 GREENWAY ROAD, EDGEWOOD ROAD, CLYDE BANK ROAD TO LOCH RAVEN  
13 BOULEVARD, TAYLOR AVENUE TO PLEASANT PLAINS ROAD, BARKSDALE ROAD  
14 TO GLEN KEITH BOULEVARD TO LASALLE ROAD, AND PUTTY HILL AVENUE TO  
15 DRUMWOOD ROAD- ; AND

16 (2) The area of Arbutus consisting of the area north of Selford Road and South  
17 Rolling Road, east and south of Wilkens Avenue, south of Maiden Choice Lane, west of Leeds  
18 Avenue, Linden Avenue, and East Drive, and north of Sulphur Spring Road at its intersection with  
19 Selford Road.

21 SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed by  
22 the affirmative vote of five members of the County Council, shall take effect on March 6, 2017.
