AN ACT concerning

The 2016-2017 Current Expense Budget
Gifts and Grants Special Revenue Fund
HCCT and Central Office

FOR the purpose of amending the 2016-2017 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from state funds and made available to the County through the Maryland Department of Labor, Licensing and Regulation.

WHEREAS, the Maryland Department of Labor, Licensing and Regulation has made an award of state funds available to the Baltimore County Department of Economic and Workforce Development, to be used to provide Construction Apprenticeship Preparation Core Training plus

welding to up to 32 trainees during the grant term (retroactive to the grant commencement date of January 1, 2017); and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2015, as amended, the County Council may accept gifts and grants, appropriate same to the Gifts and Grants Special Revenue Fund and expend the same, said fund having been established solely for the purpose of accounting for certain monetary gifts and grants made available to the County for restricted purposes; and

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
2 COUNTY, MARYLAND, pursuant to the power and authority conferred upon it by Sections 306
3 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County
4 Code, 2015, as amended, that the Current Expense Budget for the fiscal year ending June 30,
5 2017, be and is hereby amended by appropriating state funds made available to the Baltimore
6 County Economic and Workforce Development, in the amount herein specified, to the following
7 program:

1 SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed by
2 the affirmative vote of five members of the County Council, shall take effect March 19, 2017.
