FOR the purpose of defining the term "Semi-Public Swimming Pool;" providing for its applicability; providing for required signage at a semi-public swimming pool; and generally relating to swimming pools.

SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE

2 COUNTY, MARYLAND, that the Laws of Baltimore County read as follows:

1	ARTICLE 13 – PUBLIC HEALTH, SAFETY, AND THE ENVIRONMENT
2	Title 6 – Swimming Pools and Bathing Beaches

4	§ 13-6-201. Definitions.
5	(a) In general. In this subtitle, the following words have the meanings indicated.
6	(b) "Approving Authority" means the Health Officer of the Health Officer's designee.
7	(c) Private swimming pool. "Private swimming pool" means a swimming pool located on a
8	private residential property under the control of a single resident, the use of which is limited to
9	members of the resident's family and invited guests.
10	(d) Public bathing beach.
11	(1) "Public bathing beach" means a natural bathing beach together with any buildings,
12	appurtenances, or other improvements, at a pond, lake, quarry, stream, or bay, intended to be used
13	collectively by numbers of individuals for swimming or recreational bathing, regardless of whether
14	a fee is charged for use.
15	(2) "Public bathing beach" includes a bathing beach at a private club.
16	(e) Public swimming pool.
17	(1) (i) "Public swimming pool" means a swimming pool intended to be used collectively
18	by numbers of individuals for swimming or bathing, operated by any person including an owner,
19	lessee, operator, licensee, or concessionaire, regardless of whether a fee is charged for use.
20	(ii) "Public swimming pool" includes a swimming pool at a private club.
21	(2) "Public swimming pool" does not include a SEMI-PUBLIC SWIMMING POOL OR
22	A private swimming pool.
23	(F) SEMI-PUBLIC SWIMMING POOL. "SEMI-PUBLIC SWIMMING POOL" MEANS A

- 1 SWIMMING POOL THAT IS LOCATED AT A FACILITY WHICH IS A TEMPORARY
- 2 DWELLING TO INCLUDE A HOTEL, MOTEL, OR SIMILAR TEMPORARY DWELLING,
- 3 FOR USE BY GUESTS AT THE FACILITY.
- 4 [(f)] (G) Swimming pool.
- 5 (1) "Swimming pool" means an artificial structure, basin, chamber, or tank containing a
- 6 body of water for the primary purpose of swimming, diving, or recreational bathing.
- 7 (2) "Swimming pool" includes a wading pool.
- 8 [(g)] (H) Wading pool. "Wading pool" means a swimming pool not normally in excess of 2 feet
- 9 deep at its maximum depth and usually reserved for use by small children.

- 11 § 13-6-204. Health and Safety Requirements.
- 12 (c) Lifeguards.
- 13 (1) In this subsection, a "competent lifeguard" is a lifeguard who holds a current
- 14 American Red Cross senior lifesaving certificate or its equivalent.
- 15 (2) During all swimming periods, the operator of a public swimming pool or public
- 16 bathing beach shall provide:
- 17 (i) A minimum of one competent lifeguard; and
- 18 (ii) An adequate number of additional competent lifeguards as required by the
- 19 approving authority.
- 20 (3) A SEMI-PUBLIC SWIMMING POOL THAT DOES NOT HAVE A LIFEGUARD
- 21 ON DUTY SHALL HAVE A CONSPICUOUS SIGN POSTED ADJACENT TO ENTRANCES
- 22 TO THE POOL READING "WARNING; NO LIFEGUARD ON DUTY. SWIM AT YOUR
- 23 OWN RISK. DO NOT SWIM ALONE. CHILDREN UNDER 18 SHOULD NOT USE THE

1 POOL WITHOUT ADULT SUPERVISION."

- 3 SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed by
- 4 the affirmative vote of five members of the County Council, shall take effect on June 7, 2017.
