## A BILL ENTITLED

### AN ACT concerning

Zoning Regulations - Licensed Arborist

FOR the purpose of providing for the definition of the term "Licensed Arborist" in the Baltimore County Zoning Regulations; permitting a Licensed Arborist under certain circumstances in the B.L. Zone; and generally relating to Licensed Arborists.

# BY adding

Section 101.1, the definition of "Arborist, Licensed," listed alphabetically, and Section 230.1.A.9, the permitted use "Arborist, Licensed" listed alphabetically Baltimore County Zoning Regulations

1	SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
2	COUNTY, MARYLAND, that the Baltimore County Zoning Regulations read as follows:

4	Section 101 – Definitions.
5	§ 101.1. Word usage; definitions.
6	Words used in the present tense include the future; words in the singular number include the plural
7	number; the word "shall" is mandatory. For the purposes of these regulations, certain terms and
8	words are defined below.
9	Any word or term not defined in this section shall have the ordinarily accepted definition as set
10	forth in the most recent edition of Webster's Third New International Dictionary of the English
11	Language, Unabridged.
12	ARBORIST, LICENSED – A PERSON OR BUSINESS, LICENSED BY THE STATE OF
13	MARYLAND, AND LICENSED AS A TREE EXPERT IN ACCORDANCE WITH THE
14	REQUIREMENTS OF THE NATURAL RESOURCES ARTICLE OF THE ANNOTATED
15	CODE OF MARYLAND, WHO CARES FOR, MAINTAINS, PLANTS, TRIMS, OR
16	REMOVES TREES FROM COMMERCIAL, RESIDENTIAL, OR PUBLIC LANDS, AND
17	WHO KEEPS AND MAINTAINS THE COMMERCIAL VEHICLES AND EQUIPMENT
18	NECESSARY TO CARRY OUT THAT PURPOSE.

20	Section 230. Business, Local (B.L.) Zone Use Regulations.
21	§ 230.1. Permitted uses.
22	A. The following uses only are permitted:
23	9. ARBORIST, LICENSED, PROVIDED THAT NO MATERIALS ARE KEPT OR

1	STORED UPON THE PREMISES LOCATED IN THE PARKVILLE COMMERCIAL
2	REVITALIZATION DISTRICT, AND PROVIDED THAT NO ACTIVE TREE WORK IS
3	PERFORMED, NO RETAIL SALES OCCUR, AND NO MATERIALS INLCUDING TREE
4	LIMBS, FIREWOOD, MULCH, WOOD CHIPS OR SIMILAR MATERIALS ARE KEPT OR
5	STORED, UPON THE PREMISES. IN ADDITION, APPROPRIATE SCREENING OF THE
6	PROPERTY SHALL BE INSTALLED, TO THE EXTENT POSSIBLE, IN ACCORDANCE
7	WITH THE BALTIMORE COUNTY LANDSCAPE MANUAL.

9	SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed by

10 the affirmative vote of five members of the County Council, shall take effect on June 7, 2017.
