Circuit Court Security Grant

FOR the purpose of amending the ~~2016-2017~~ 2017-2018 Current Expense Budget, by
appropriating to the Gifts and Grants Special Revenue Fund monies derived from state
funds and made available to the County through the Administrative Office of the Courts.

WHEREAS, the Administrative Office of the Courts has made an award of state funds
available to the Circuit Court for Baltimore County to be used to upgrade the duress alarm
system throughout the Court; and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County
Charter and Section 10-6-102 of the Baltimore County Code, 2015, as amended, the County

Council may accept gifts and grants, appropriate same to the Gifts and Grants Special Revenue Fund and expend the same, said fund having been established solely for the purpose of accounting for certain monetary gifts and grants made available to the County for restricted purposes; and

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
2 COUNTY, MARYLAND, pursuant to the power and authority conferred upon it by Sections 306
3 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County
4 Code, 2015, as amended, that the Current Expense Budget for the fiscal year ending June 30,
5 ~~2017~~ 2018, be and is hereby amended by appropriating state funds made available to the Circuit
6 Court for Baltimore County, in the amount herein specified, to the following program:
