#### A BILL ENTITLED

#### AN ACT concerning

Medical Cannabis Facilities - Location

FOR the purpose of providing that a medical cannabis dispensary may not be located within a certain distance of property owned by the Baltimore County Board of Education; requiring certain notification; and generally relating to the location of medical cannabis facilities.

BY repealing and re-enacting, with amendments

Section 4D - 102 Baltimore County Zoning Regulations

- SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
- 2 COUNTY, MARYLAND, that the Baltimore County Zoning Regulations read as follows:

A. Permitted areas. 2 1. A medical cannabis dispensary is permitted in the B.R., B.M., B.L., B.L.R., 3 M.L., and O-3 Zones by right. 4 2. A medical cannabis dispensary is permitted only by special exception in a 5 B.R., B.M., B.L., B.L.R., or O-3 Zone that is located in a Commercial Revitalization District. 6 3. A medical cannabis dispensary is not permitted in an M.L. zone if located in a 7 8 Chesapeake Enterprise Zone. B. A medical cannabis dispensary may not be located: 9 1. Within 500feet of a public or private elementary school, middle school, or high 10 11 school; or 2. WITHIN 800 FEET OF PROPERTY OWNED BY THE BALTIMORE 12 COUNTY BOARD OF EDUCATION AND IDENTIFIED AS A FUTURE SCHOOL SITE; OR 13 [2.] 3. Within 2,500 feet of another medical cannabis dispensary. 14 C. All setbacks under Subsection B shall be measured from the nearest property line of 15 16 the medical cannabis dispensary using a direct line to the nearest property line of the school, or other dispensary, OR BOARD OF EDUCATION PROPERTY. 17 D. A COPY OF THE APPLICATION FOR A PERMIT OR SPECIAL EXCEPTION 18 19 SHALL BE SENT TO THE COUNCILMEMBER IN WHOSE DISTRICT THE MEDICAL
